ALLOTMENT TO PROFESSIONAL DEGREE COURSES (KEAM 2017) THIRD PHASE ALLOTMENT PUBLISHED

The third phase allotment to Professional Degree Courses in Kerala -2017 is published on the website www.cee.kerala.gov.in. In this phase, allotment is done to MBBS, BDS, Ayurveda, Agriculture, Forestry, Veterinary and Fisheries courses in addition to Engineering, Architecture and Pharmacy courses.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should invariably take a printout of the third phase allotment memo for payment of fees and for taking admission in the college.

Those candidates who receive an allotment afresh or a change in allotment to Engineering, Architecture or Pharmacy courses should remit the fee/balance fee, if any, to be paid to the Commissioner for Entrance Examinations as specified in the third phase allotment memo at any of the designated branches of State Bank of India or by way of Online Payment from 21.07.2017 to 25.07.2017 and should join the course/college allotted before 5 pm on 25.07.2017.

In case of allotment to Medical & Allied courses, the last date for remittance of fee/balance fee and joining the course/college allotted is 30.07.2017.

Those candidates who do not remit the fee/balance fee and who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.

In this phase, allotments have been done to the seats earmarked under Community/Registered Trust/ Registered Society Quota in Private Self Financing Engineering/Architecture colleges and to the Minority Quota seats in Private Self Financing Pharmacy colleges.

The allotments done on the basis of the orders of the Hon'ble High Court of Kerala to the new courses/additional intake in some Private Self Financing Engineering/Architecture colleges and to certain Private Self Financing Pharmacy colleges shall be provisional and subject to the final outcome of the related Writ Petitions.

Note: This allotment is the last phase of allotment to Private Self Financing Engineering/Architecture colleges and all the Self Financing Pharmacy colleges. Hence the students who get allotment in such colleges should invariably join the colleges allotted, before 5 pm on 25.07.2017. Otherwise they are liable to pay the Liquidated Damages as per

clause 12.2.4 (c) of the Prospectus for KEAM-2017/Pharmacy Courses. Also they will not be eligible for the refund of fees, if any, paid to the Commissioner for Entrance Examinations.

The availability of higher order options of candidates who are allotted to Private Self Financing Engineering/Architecture colleges after this allotment and levying of Liquidated Damages in the event of discontinuing the course after 25.07.2017 from such colleges shall be as per the provisions in GO(Ms)No. 166/2017/H.Edn. dated 22.06.2017, GO(Ms)No. 170/2017/H.Edn. dated 23.06.2017 and GO(Ms)No. 169/2017/H.Edn. dated 23.06.2017. However, liquidated damages may not be collected from the students admitted to Private Self Financing Engineering/Architecture colleges (except colleges under Kerala Catholic Engineering College Managements Association) who leave the course/college for getting admission in Medical & Allied courses through KEAM-2017. But the fees remitted by such students for the year shall not be refunded.

The levying of liquidated damages in the event of discontinuing the course after 25.07.2017 from Self Financing Pharmacy colleges shall be as per the provisions in GO (Rt) No. 1781/2017/H & FWD dated 27.06.2017, GO (Rt) No. 1814/2017/H & FWD dated 28.06.2017 and GO (Rt) No. 1813/2017/H & FWD dated 28.06.2017. All the above Government Orders are available in the section 'Government Orders' in the website www.cee-kerala.org.

<u>Note</u>:- (1) The Category lists for the following categories- BH, BX, DV, EC, EO, EZ, KN, LA, LG, MU, OE, SC, SD, VA and VK have been revised after considering the certificates/documents received in respect of various claims. The allotments are done on the basis of the revised category lists. The revised category-wise lists are available in the above websites.

(2) The allotment to the seats earmarked for 'Live Stock Inspectors' Under BV.Sc & A H course has not been done in this phase. Allotment to these seats shall be done in the next phase after rectification of defects in the above category list.

Candidates are advised to go through the various clauses relating to Liquidated Damages in the Prospectus and the relevant Government Orders available in the above website.
