## **KEAM 2016**

## THIRD PHASE OF ALLOTMENT TO PROFESSIONAL DEGREE COURSES ONLINE OPTION CONFIRMATION IS MANDATORY

The activities related to the third phase of allotment to Professional Degree Courses 2016 will begin on 16.07.2016. In this phase, allotment will be done to Engineering, Architecture, Agriculture, Veterinary, Fisheries and Forestry courses only. All the candidates who want their higher order options to be considered for this phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After Online Option Confirmation, the candidates can re-arrange / delete their higher order options and also register fresh options to the newly added Courses/Colleges from 16.07.2016 to 19.07.2016, 3 pm, through the website www.cee.kerala.gov.in . The allotment on the basis of options received upto 3 pm on 19.07.2016, will be published on 20.07.2016. The candidates who have an allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations in one of the designated branches of the State Bank of Travancore (SBT)or by way of online payment and should join the allotted course/college before 5 pm on 25.07.2016. The list of designated branches of SBT is available on the website.

## The detailed schedule for the allotment is furnished below.

16.07.2016	Website opens for <b>Online Option Confirmation</b> and for enabling rearrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.		
19.07.2016 (3 pm)	Time for Online Option Confirmation and re-arrangement/deletion/addition of options ends		
20.07.2016	Publication of Allotment		
21.07.2016 to 25.07.2016	In all the courses, candidates who have received allotment should remit the fee /balance fee payable in SBT or by way of online payment and should report before the college authorities to join the allotted college/course.		
25.07.2016, 5.30 pm	5.30 pm All the college authorities should approve and submit the list of admitted candidates through OAMS.		

Those who do not confirm their options online will not be considered for this phase of allotment. Also their higher order options in Engineering, Architecture, Agriculture, Veterinary, Fisheries and Forestry courses will be removed and will not be available in the subsequent phases. However, his/her existing allotment shall be retained if he/she has joined the college as per the second phase allotment.

The Colleges and Courses for which fresh options can be registered in this phase of allotment are furnished below:

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies / Affiliation from the Universities.

Note: The Allotment to be published on 20.07.2016 is the last phase of allotment to Private Self Financing Engineering/Architecture colleges. Hence the students who get allotment in such colleges should invariably join the colleges allotted, before 5 pm on 25.07.2016. Otherwise they are liable to pay the Liquidated Damages as per clause 12.2.4 (c) of the Prospectus for KEAM-2016.

The higher order options in Engineering/Architecture courses of candidates who are allotted to Private Self Financing Engineering/Architecture colleges shall be deleted after this allotment as per the existing Government Orders. However, liquidated damages may not be collected from the students admitted to Private Self Financing Engineering/Architecture Colleges (except Colleges under Kerala Catholic Engineering College Managements Association) who leave the course/college for getting admission in Medical & Allied courses through KEAM-2016. But the fees remitted by such students for the year shall not be refunded.

Candidates are advised to go through the various clauses relating to Liquidated Damages in the Prospectus and the relevant Government Orders available in the above website.
