CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES, KERALA-2016

SECOND PHASE ALLOTMENT PUBLISHED

The Second phase allotment to Professional Degree Courses, Kerala -2016 is published on the website <u>www.cee.kerala.qov.in</u>. During the second phase, allotment is done to MBBS, BDS and other Medical Allied courses in addition to Engineering/Architecture courses.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should take a printout of the second phase allotment memo and produce it before the authorities of **State Bank of Travancore (SBT)** for payment of fee/balance fee. The list of designated branches of **SBT** is available on the website. The fee/balance fee can be paid by way of online payment also.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the second phase allotment memo at any of the designated branches of State Bank of Travancore or by way of online payment on any date from 11.07.2016 to 15.07.2016 and should join the course/college allotted before 5 pm on 15.07.2016.

The candidates who get a change in allotment than that of the first allotment should pay the balance fee, if applicable, in a designated branch of SBT or by way of online payment on any date from 11.07.2016 to 15.07.2016 and should join the course/college allotted as per the second phase allotment memo before 5 pm on 15.07.2016.

Thus all the candidates who have an allotment after the second phase should join the course/college allotted as per the second phase allotment memo before 5 pm on 15.07.2016. The detailed schedule showing the date and time for joining the Engineering/Architecture courses is published in the website <u>www.cee-kerala.org</u>. The candidates who are not able to join the course/college as per the schedule can join the college before 5 pm on 15.07.2016 by intimating the college authorities concerned.

Those candidates who do not remit the fee/balance fee within the stipulated time and who do not join the course/college allotted within the stipulated time will lose their allotment and also their existing higher options. They will not be considered for further online allotments for the existing options.

The third phase of Allotment to Professional Degree courses will be published on 20th July, 2016. Facility for rearranging/deleting the existing options and for online option confirmation will be provided before the third round of allotment.

Important: The third phase of allotment will be the last round of allotment to Private Self Financing Engineering/Architecture Colleges. Candidates allotted to Private Self Financing Engineering/Architecture Colleges in the third phase should invariably join the allotted colleges. Otherwise they will be liable to pay the Liquidated Damages as per clause 12.2.4 of the Prospectus and the existing Government orders. The fee paid by such students will not be refunded. Also the higher options of such candidates shall be deleted as per the existing Government orders.
