CENTRALISED ALLOTMENT TO PROFESSIONAL DEGREE COURSES
FIRST PHASE ALLOTMENT TO MEDICAL & ALLIED COURSES PUBLISHED

The first phase allotment to Medical & Allied courses in the State for the year 2018-19 is published herewith on the websites www.cee.kerala.gov.in and www.cee-kerala.org. The allotment list in PDF format prepared in the rank order contains allotted course, college, category of allotment etc. and is available in the above websites. The allotment is based on the online options filed by the candidates up to 12 noon on 03.07.2018 through the above website. Allotment has been done in this phase to the NRI Quota seats in Self Financing Medical & Dental Colleges and to the Minority Quota seats in Private Self Financing Medical & Dental colleges having Minority status.

The details of allotment of a candidate will be made available on the home page of the candidate later. Candidates who have an allotment can take the printout of the Allotment Memo from their home page from 9 am on 06.07.2018 onwards. All the candidates who have an allotment should take the printout of the first phase allotment memo which will show the details such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, details of Fee to be paid etc. Candidates who receive an allotment shall have to remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the first phase allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** from **06.07.2018 to 5 pm on 12.07.2018** in order to accept the allotment. The list of Post Offices having facility for fee payment is available in the website.

Fees:

- Candidates allotted to NRI quota seats in Self Financing Medical Colleges have to remit Rs. 5 lakhs to the Commissioner for Entrance Examinations and balance amount to the college at the time of admission.
- Candidates allotted to Government/Minority quota in Self Financing Medical colleges and those allotted to Government/Minority/NRI quota in Self Financing Dental colleges shall have to remit Rs. 1 lakh to the Commissioner for Entrance Examinations and the balance fee to the colleges at the time of admission.
- Candidates allotted to Medical & Allied courses in Government/Aided colleges and colleges under Kerala Agriculture/Veterinary/Fisheries Universities shall have to remit the full fee to the Commissioner for Entrance Examinations.

Token Deposit:

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have to remit a token deposit of **Rs. 1000/-** to the Commissioner for Entrance Examinations as token of having accepted the allotment and should join the college allotted on any date from 06.07.2018 to 5 pm on 12.07.2018.

Candidates who get allotment to Medical & Allied courses in this phase shall have to join the allotted college on any date from 06.07.2018 to 5 pm on 12.07.2018 after remitting the fee to be paid to the Commissioner for Entrance Examinations. Balance fee, if any, to be paid as per the allotment memo shall have to be remitted at the time of admission in the colleges.

Those candidates who do not remit the fee and join the college allotted within the stipulated time will lose their allotment as well as all the existing options in the stream to which the allotment belongs. The options once lost will not be available in the subsequent phases.

Allotment has not been done in this phase to the four Medical Colleges [*Azeezia Institute of Medical Science and Research, Kollam (AZC), Kannur Medical College, Kannur (KNC), Dr. Somervell Memorial CSI Medical College, Karakonam, Thiruvananthapuram (SMC), SUT Academy of Medical Sciences, Vattappara, Thiruvananthapuram (SUC)*] and two Dental colleges [*Indira Gandhi Institute of Dental Sciences, Kothamangalam, Ernakulam (IGD), Kannur Dental College, Anjarakandy, Kannur (KAD)*] for want of Affiliation from the University concerned. Also, allotment has not been done to the college under Kerala Agricultural University [*College of Agriculture, Ambalavayal, Wayanad (COW)*] for want of necessary Government orders. The above colleges shall be included in the Centralized Allotment Process as and when the required orders are received.

Note: The first phase allotment published on 04.07.2018 is provisional and subject to the final orders of the Hon'ble High Court of Kerala on WP(C)No. 21686 of 2018.
