# KEAM-2022 ADMISSION TO MBBS/ BDS COURSES MOP UP ALLOTMENT PUBLISHED

The mop up allotment to MBBS/BDS Courses for the year 2022 is published on the website of Commissioner for Entrance Examinations **www.cee.kerala.gov.in**. As per the judgment from the Hon'ble High Court in WP(C) No.40010 of 2022, dated 13.12.2022, the notification published by the Commissioner for Entrance Examinations on 07.12.2022 has been revised and provisional Mop up allotment was published according to the revised guidelines. The mop-up allotment is published because the writ petitions filed by candidates against the revised notification have been dismissed, and the legal opinion is to proceed with the mop-up allotment, which was published provisionally on the basis of the revised guidelines.

Candidates who are admitted in MBBS/BDS Courses up to All India Second round allotment, up to State quota second round allotment and All India Mop up allotment have been excluded from the Mop up allotment. The Mop up allotment has been published after addressing the valid complaints received from candidates, against the provisional mop up allotment list published on 14/12/2022.

The allotted candidates can take printout of the allotment memo from the candidate portal. The details of allotment of a candidate such as **Name**, **Roll Number**, **Allotted Course**, **Allotted College**, **Category of Allotment**, **Fee details** etc. will be available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment should remit the fees as shown in the allotment memo to the allotted college and should join the course/ College allotted from 17/12/2022 to 18/12/2022.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not pay the tuition fee . However, if they are allotted seat under Minority/NRI quota seats in Self-financing Medical/Dental colleges they will have to remit the fee as shown in the allottment memo and they will not be eligible for any fee concession.

Candidates who have an allotment can download the 'Data Sheet' containing the basic

details of the candidates by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission.

Those candidates who have an allotment should join the course/college as per the allotment before **4.00 PM on 18.12.2022**. Those candidates who do not join the course/college allotted within the stipulated time will lose their allotment and the Mop up Registration fee of such candidates will not be refund. Those candidates, who quit seats after taking admission either through Mop up allotment or through previous allotments conducted by Commissioner for Entrance Examinations, will be penalized as per KEAM Prospectus clause 12.2.4.

If any vacancy exists in MBBS/BDS courses after Mop-up allotment, it will be filled up through Stray vacancy Allotment, by considering the same options registered by the candidates through Mop up allotment. Those candidates who do not join after getting an allotment though Mop-up allotment and those who quit the seats after joining college through Mop-up allotment, they will not be considered for stray vacancy allotment. Details of stray vacancy allotment will be published later.
