## ADMISSION TO INTEGRATED FIVE YEAR LL.B COURSE 2022 ONLINE OPTIONS INVITED

The activities related to the Centralised Allotment Process (CAP) for admission to Integrated Five Year LL.B Course in four Government Law Colleges and Government seats in 19 Private Self-financing Law Colleges of the State for the year 2022-23 commences from **27.10.2022**.

Candidates included in the rank list can register their options online through the website www.cee.kerala.gov.in from. 27.10.2022 to 03.11.2022, 3.00 PM. Candidate may enter their Application Number & Password in the link 'Integrated Five Year LL.B 2022 - Candidate Portal' provided in the above website to log on to their home page. Then by clicking the menu item 'Option Registration' candidates can register their options online. The first allotment based on the online options received upto 3.00 PM on 03.11.2022 will be published provisionally on 05.11.2022 and Final Allotment will be published on 07.11.2022.

Candidates whose results are withheld due to defects in nationality proof submitted online can also register online options. If relevant documents are not uploaded by such candidates till **02.11.2022, 3.00 PM** their options will not be considered for the allotment process.

Candidates who fail to register their options online will not be considered for allotment under any circumstances. Options submitted to the Commissioner for Entrance Examinations by Fax/Post/Hand delivery will not be processed or considered on any account for the allotment of seats.

- Candidates who receive allotment should have attained the eligibility for admission as per **Clause 6** of the Prospectus at the time of admission.

## Documents to be produced at the time of admission

- 1. Candidate's Data Sheet.
- 2. Allotment memo issued by the Commissioner for Entrance Examinations.
- 3. SSLC or any relevant school records/birth certificate/passport/other valid document to prove date of birth in original.
- 4. Original Mark list and Pass Certificate of the qualifying examination.
- 5. Transfer Certificate and Conduct Certificate from the institution where the Candidate studied last.
- 6. Four copies of recent passport size photograph.
- 7. The applicant who is employed or trainee in Government/Quasi Government/Banks etc. shall, at the time of interview, produce a relieving order and a certificate of good conduct from the Head of the Institution where the candidate was employed.
- 8. Candidate who passed their qualifying examination from Universities/Boards outside the state shall produce an "Eligibility Certificate" from the concerned University in Kerala, to the effect that the qualifying examination has been recognised by the University. The students opting for Law Colleges under various Universities in Kerala should have obtained the Eligibility Certificate from the University concerned sufficiently before the submission of online options for allotment under Centralised Allotment Process (CAP).
- 9. The student who qualifies from other Universities should produce migration certificate at the time of admission or before the commencement of first semester examination.
- 10. Originals of all the uploaded documents/certificates (to prove nativity /reservation/fee concession).
- 11. Any other certificates/documents required to be furnished as per the prospectus/notifications/allotment memo.

**Note :-**Candidates are advised not to give unnecessary options to courses/colleges where they do not wish to join. Candidates are advised to visit the official website of Commissioner for Entrance Examinations for Notifications and latest updates.
