ADMISSION TO POST GRADUATE NURSING COURSES (MSc Nursing)-2022 FIRST PHASE ALLOTMENT LIST PUBLISHED

The First phase of Centralised Allotment for admission to Post Graduate Nursing Courses for the academic year 2022-23 in Government Nursing Colleges and Private Self Financing Law colleges in the state is published in the website **www.cee.kerala.gov.in**. The allotment is based on the rank in the rank list of Post Graduate Nursing Courses published by the Commissioner for Entrance Examinations and online options registered by candidates from 01.11.2022 to 06.11.2022, 4.00 PM. Provisional List for First Phase Allotment was published on 08.11.2022 in the website of the Commissioner for Entrance Examinations. Final allotment to the course has been published after addressing complaints on Provisional Allotment List from candidates received up to 12.00 PM of 09.11.2022.

Candidates can access their homepage by entering their application number, and password in the '<u>PG Nursing 2022-Candidate Portal</u>' provided in the website. Then by clicking the menu item 'Allotment Result' candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc. are available in the allotment memo. The candidate shall take a print out of the allotment memo. Candidates can log into their Home Page and then click the Menu Item 'Data Sheet' for downloading the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges from **11.11.2022** to **15.11.2022**, **3.00** PM along with the allotment memo and original documents specified in Clause 12(C) of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **15.11.2022**, **5.00** PM.

concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

The candidates who do not join the college as per the specified dates, will lose their present allotment and their higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments(if any) will be notified later.
