ADMISSION TO MSc NURSING (PG Nursing) COURSE -2022 CANDIDATES CAN REGISTER NEW OPTIONS FOR ONLINE MOP UP COUNSELING

The activities related to the Mop Up Counseling for admission to MSc Nursing Course for the academic year 2022-23 in various Government and self-financing nursing colleges commenced from **21.11.2022**. The Mop-Up Counseling is conducted for filling the vacancy existing in or probable vacancies that may arise in various nursing colleges due to transfer of students who have already joined the course or due to ongoing second phase admission process. All Candidates who have figured in the rank list/Category list published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 7 in the MSc Nursing Prospectus-2022 can participate in the Mop Up Counseling.

Candidates who have obtained admission in Kerala Government merit seats for a Nursing course through first or second phase of centralized allotment in any of the Govt. Nursing Colleges shall not be eligible to participate in the Mop-Up Counseling for the same Specialty in other Govt Nursing Colleges, like wise, who have obtained admission in Government merit seats for a course in any of the Self Financing Nursing colleges shall not be eligible to participate in the Mop-Up Counseling for the same subject in other Self Financing Nursing colleges. However a candidate who got admission in Government merit seat of a Self Financing Nursing College shall be permitted to take admission in the same/other subject in a Government Nursing College through Mop-Up Counseling.

Those candidates who have already been admitted in MSC Nursing Course through first phase or second phase of allotment, if they get an allotment through this Mop Up Counseling will lose the existing admission. Candidates can register options to all the courses other than specified above, existing in Government/Self-financing colleges irrespective of vacancy status in each nursing colleges to which the candidate wish to join, as the newly vacant seats due to transfer of students who have already secured admission, will also be filled in this Counseling. The options submitted by the candidates for previous phases will be treated as void. Fresh option registration is mandatory for participating in the Online Mop up

Counseling.

Note:

Those candidates who do not register their options within the stipulated time will not be considered for the Counseling.

Online Option Registration is mandatory in this phase.

Candidates who wish to participate in the Mop up Counseling shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link "PG Nursing 2022 – Candidate Portal". Then by clicking the Menu item 'Option Registration', candidate can register their options online within the stipulated time

The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the prospectus clause 12 (c) and the tuition fee, other fees and the deposits (if applicable) should be remitted at the allotted colleges at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for educational concessions as is given to OEC/Candidates eligible for fee concession as per GO(Ms)No.25/2005/SCSTDD dated: 20.06.2005/Children of Fisherman/Inmates of Sri Chithra home, Nirbhaya home & Juvenile home allotted under Government Quota are exempted from payment of fees.

All the College Principals should approve and submit the list of admitted candidates through OAMS before 28.11.2022,4.00 PM
