# <u>ALLOTMENT TO MBBS,BDS,AGRICULTURE,VETERINARY,FORESTRY,FISHERIES</u> <u>COURSES PUBLISHED</u>

The second phase allotment to MBBS, BDS courses and third phase allotment to Agriculture, Veterinary, Forestry and Fisheries courses in the State for the year 2019-20 is published herewith on the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a>. The allotment is based on the online options filed by the candidates up to 5 pm on 29/07/2019 through the above website. Candidates included in the list furnished by Ministry of Health and Family Welfare, Government of India as admitted under All India Quota MBBS/BDS seats have not been considered for the allotment to Medical and Allied courses in the state.

The details of allotment of a candidate are available on the home page of the candidate. All the candidates who have an allotment should take the printout of the Allotment Memo which will show the details such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, details of Fee to be paid etc. Candidates who receive an allotment afresh or a change in allotment than the previous one shall have to remit the fee/balance fee, if any, to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** from **01/08/2019** to **05/08/2019** and should join the course/college allotted before **5 pm on 05/08/2019**. The list of Post Offices having facility for fee payment is available in the website.

#### Fees:

- Candidates allotted to MBBS Course under NRI quota seats in Self Financing Medical Colleges have to remit Rs. 5 lakhs to the Commissioner for Entrance Examinations and balance amount to the college at the time of admission.
- Candidates allotted to Government/Minority quota seats in Self Financing Medical colleges and those allotted to Government/Minority/NRI quota seats in Self Financing Dental colleges shall have to remit Rs. 1 lakh to the Commissioner for Entrance Examinations and the balance fee to the colleges at the time of admission.
- Candidates allotted to MBBS/BDS courses in Govt. Medical/Dental Colleges and Agriculture, Veterinary, Forestry and Fisheries courses under Kerala Agriculture/Veterinary/Fisheries Universities shall have to remit the full fee to the Commissioner for Entrance Examinations and then join the college allotted.

### **Token Deposit:**

Candidates getting allotment afresh who belong to SC/ST/OEC/Children of Registered Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have no token deposit to the Commissioner for Entrance Examinations. They should join the college allotted before 5 pm on 05/08/2019.

Those candidates who do not remit the fee/balance fee (if applicable) and join the college allotted within the stipulated time will lose their allotment as well as all the existing higher options. The options once lost will not be available in the subsequent phases if any.

#### Mop-up Counselling for MBBS courses

Vacant seats, if any, under MBBS courses remaining after 05/08/2019 will be filled up through a Mop-up Counselling by the Commissioner for Entrance Examinations. All candidates included in the Medical rank list and qualified for MBBS course can participate in the Mop-up Counselling. But candidates who stand admitted under All India Quota MBBS/BDS seats shall not be allowed to participate in the Mop-Up counselling. The detailed notification including the date and venue of Mop-up Counselling will be published later.

As per the directions from the Hon. Supreme Court& Government of Kerala, if there will be any vacancy in NRI quota seats, after considering all the students from the NRI Categry list published by the CEE, the students with all the required original NRI documents irrespective of their domicile, will be considered for admission on the basis of their rank order.
