SECOND ALLOTMENT TO B.PHARM (LE) COURSE 2020 FACILITY FOR ONLINE OPTION CONFIRMATION

The second phase of the Centralised Allotment Process for admission to B. Pharm (LE) Course in the Government Pharmacy Colleges and Private Self-financing Pharmacy Colleges of the State for the year 2020-21 commences on **29.06.2021** (Tuesday).

Candidates who have already got allotment in various Pharmacy Colleges and those who have no allotment through the first phase of allotment can confirm online options to be considered for second phase of online allotment.

Candidates who want to participate in this phase of allotment must compulsory confirm their existing options by clicking the 'confirm' button available in their home page. After online option confirmation, such candidates can delete the unwanted higher options and can rearrange their existing higher options.

The facility for online option confirmation/deletion/rearrangement will be available on the website www.cee.kerala.gov.in from 29.06.2021 to 05.07.2021, 11.00 am. Those who do not confirm their options online within the stipulated time will not be considered for this phase of allotment.

Candidate may enter their Application Number & password in the link 'B. Pharm (LE)2020-Candidate Portal' provided in the above website to log on to their home page. Then by clicking the menu item 'Option Registration' candidates can register their options online. The allotment based on the online options received up to 11.00 am on 05.07.2021 Will be published on 06.07.2021. Candidates who get allotment shall have to join the allotted colleges from 07.07.2021 to 09.07.2021, 5.00 pm.

The annual tuition fees in self-financing pharmacy colleges is provisional and will be subject to be final decision of Government/AFRC. The annual tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission. SC/ST/OEC/Children of Fisherman/inmates of Sri Chithra Home, Nirbhaya Home and Juvenile Home candidates are exempted from payment of fees.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.

Documents to be produced at the time of admission

- i) Candidate's Data Sheet issued by Commissioner for Entrance Examinations.
- ii) Allotment memo issued by the Commissioner for Entrance Examinations.
- iii) SSLC or any relevant school records/birth certificate/passport/other valid document to prove date of birth in original.
- iv) Mark list of B. pharm Part I and Part II examination
- v) Diploma in Pharmacy Certificate from the 'Board of Diploma in Pharmacy Examination', Directorate of Medical Education, Government of Kerala/any other Board/University approved by Pharmacy Council of India.
- vi) Registration Certificate from the State Pharmacy Council of Receipt of submission of application for registration with State Pharmacy Council.
- vii) Transfer Certificate and Conduct Certificate from the institution where the Candidate studied last.
- viii) Two copies of recent passport size photograph.
- ix) Candidate who passed their qualifying examination from Universities/Boards outside the state shall produce an "Eligibility Certificate" from the concerned university in Kerala, to the effect that the qualifying examination has been recognised by the University.
- x) The student who qualifies from other Universities should produce migration certificate at the time of admission.
- xi) Originals of all the uploaded documents/certificates (to prove nativity /reservation/fee concession).
- xii) Any other certificates/documents required to be furnished as per the prospectus/notifications/allotment memo.

Candidates who do not take admission within the specified time shall lose their allotment as well as their further claims in the Centralized Allotment Process (CAP).

Those candidates whose results have been withheld due to defects in their uploaded certificates can also register options online. But the online options of such candidates will be considered for allotment only if they clear their defects by uploading the required certificate through the website www.cee.kerala.gov.in a day prior to last date allotted for option registration.

Candidates are advised not to give unnecessary options to colleges where they do not wish to join, if allotted. All details related to the allotment process and B. Pharm (LE) 2020 Prospectus are available on the website www.cee.kerala.gov.in
