ADMISSION TO B.PHARM (LATERAL ENTRY) COURSE -2021
APPLICATION INVITED

Applications are invited for the Entrance Examination for admission to B.Pharm Course [through Lateral Entry] for the academic year 2021-22 in Government and Private-Self Financing Pharmacy Colleges, in the State of Kerala.

Eligibility for Admission

- i. **Nativity:** Applicant should be an Indian citizen of Kerala origin.
- ii. **Academic qualifications:** Candidates should have studied Diploma in Pharmacy (Under Education Regulations 1991 of Pharmacy Council of India) in an institution approved by the Pharmacy Council of India and have passed the Diploma in Pharmacy examination conducted by the State Board of D.Pharm Examinations or equivalent with a minimum of 50% aggregate marks.
- iii. Candidates should have obtained registration with State Pharmacy Council and the registration Certificate is to be produced at the time of Counselling.
- iv. **Age:** There is no upper age limit for admission to the course.

Selection of candidates for B.Pharm (Lateral entry) course 2021 will be made on the basis of a Computer Based Test to be conducted by the Commissioner for Entrance Examinations (CEE) at various centres in Kerala. The examination will consist of one Paper of one and half hrs (90 minutes) duration and will have 120 Objective Type (Multiple Choice) Questions.

Submission of Online Application and Application Fee

All candidates seeking admission to B.Pharm (Lateral entry) course 2021

have to apply online through the online application portal provided in the website <https://cee.kerala.gov.in> of the Commissioner for Entrance Examinations and then remit the required fee by way of online payment or by way of e-challan available during the submission of online application. Payment through e-challan can be made in cash at Head/Sub Post Offices in Kerala. After remitting the required application fee, the candidate should upload photo and signature and all necessary Certificates /Documents. The online application portal will open on **28.06.2022** and will close at **3.00 pm of 06.07.2022**. Application or Documents submitted by any other mode will not be considered. The Acknowledgement page to be downloaded from the online application portal after completing the application submission procedure is for personal reference only and need not be sent to the office of the Commissioner for Entrance Examinations. The Acknowledgement page signifies the completion of the application submission only, and not the validity of the application or the uploaded documents which will be finalized only after the scrutiny of the application and will be acknowledged at a later stage.

Application Fee

Application Fee for General Candidates is **Rs.800/-** (Rupees Eight hundred only) and is **Rs.400/-** (Rupees Four hundred only) for SC candidates. ST Candidates are exempted from the payment of application fee. Application fee once remitted will not be refunded.

Last date and time for online submission of application

All candidates seeking admission to the course should submit the online application along with uploaded Certificates/Documents mentioned in clause 7.3.5 of the prospectus before **3.00 pm of 06.07.2022**. Late, defective and incomplete applications will be summarily rejected. No correspondence will be undertaken in this regard. Candidates can download the acknowledgement page of the online application and keep it for future reference.

Admit Cards

Admit cards for the candidates whose Applications have been accepted will be provided in the official website of the Commissioner for Entrance Examinations, <https://cee.kerala.gov.in>, prior to the computer based test.

Entrance Examination

The scheme of Computer Based Test, syllabus and the instructions to the candidates are available in clause 8 of the 'Prospectus for Admission to B.Pharm (Lateral entry) course 2021' approved by Government of Kerala.

Rank List

CEE will conduct the Entrance Examination and will publish the Rank list of candidates as per the provisions in clause 10 of the Prospectus for Admission to B.Pharm (Lateral entry) course 2021 approved by Government of Kerala.

Candidates will be allowed, neither to include any information in the application form nor to submit any certificates/Documents claiming reservation or any benefits, after the submission of the application. Candidates may go through the various provisions of the Prospectus for admission to B.Pharm (Lateral entry) course 2021 available on the Official website of the Commissioner for Entrance Examinations <https://cee.kerala.gov.in> before filling up the Online application form.
