**ADMISSION TO MBBS/BDS COURSES -2022**  
**VACANCY FILLING AFTER MOP UP ALLOTMENT**

The vacancies existing in MBBS/BDS courses in Government /Self-financing Medical colleges for the academic year 2022-23, after the Mop Up allotment, will be filled through Stray Vacancy Filling Allotment. The allotment list to fill the vacancies left over from the mop-up allotment is now available on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment list has been prepared on the basis of the online options registered by the candidates during the MBBS/BDS mop-up allotment. Candidates admitted to MBBS/BDS courses through the All India allotment or through the allotment conducted by the Commissioner for Entrance Examinations, and those candidates who received an allotment through the MBBS/BDS mop-up allotment, have not been considered in this phase of the Stray Vacancy Filling Allotment, and will not be considered in the subsequent phases, if any, of the Stray Vacancy Filling Allotment Process, also.

The details of the allotment of the allotted candidates will be available on the Home Page. Those candidates who get an allotment should take a printout of the Allotment Memo from the Home Page. The details of allotment such as **Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details** etc. will be available in the Allotment Memo.

Candidates who receive an allotment through Stray Vacancy allotment should remit the fees/balance fee (if applicable) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo by way of online payment or through any of the head post office in Kerala and should join the colleges concerned on or before **24.12.2022, 12.00 PM** with all the required documents mentioned in Prospectus clause 11.7.1.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and

those candidates from Sree Chitra home, Juvenile home, Nirbhaya are eligible for fee concession. However if they are allotted under Minority/NRI quota seats in Self-financing Medical/Dental colleges, they will have to remit the full fee prescribed and they will not be eligible for any fee concession.

Candidates who get an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item '**Data Sheet**' available on the home page of the candidate. The printout of the Data Sheet, Allotment Memo are to be produced before the college authorities at the time of admission.

The Mop up registration fee of those candidates who do not join the allotted college within the stipulated time after getting an allotment through Stray Vacancy allotment and of those candidates who lapse the seats after joining the course, will be considered as penalty and will not be refunded. Penalty will also be applicable to those candidates, who lapse the MBBS/BDS seats through Stray Vacancy allotment, as per KEAM 2022 Prospectus clause 12.2.4 (c)(ii).

Vacancies if any, existing in MBBS/BDS courses after 24.12.2022 will be filled through second phase stray vacancy allotment. Candidates who are allotted a seat at any phase of the Stray Vacancy Filling Allotment will not be considered in the subsequent phases, if any, of the Stray Vacancy Filling Allotment Process. The details of the second phase stray vacancy allotment will be published later.
