# ONLINE MOP UP ALLOTMENT TO GOVERNMENT/AIDED ENGINEERING AND ARCHITECTURE COLLEGES-2022 CANDIDATES CAN REGISTER NEW OPTIONS

The activities related to the Mop Up Allotment for admission to Engineering and Architecture Courses in the Government/Aided Engineering/ Architecture colleges for the vear 2022-23 will commence on 17.10.2022. The Mop-Up allotment is conducted for filling the vacancy existing in Government/Aided Engineering and Architecture colleges. Candidates who have figured in the rank list published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per Clause 6 in the KEAM 2022 Prospectus can who Mop Up allotment. Candidates participate in the got admission in Government/Aided /Private Self financing and Government Cost-sharing colleges in the previous phases, those who have not taken admission after allotment, those who have obtained Transfer Certificate after admission and those who have not yet received any allotment can participate in this Mop Up Allotment process. However the allotment/admission of those candidates who have already taken an admission or take admission before 19.10.2022, 3.00 PM in any of the Private Self-financing Engineering and Architecture colleges will be subject to the orders of the Government in this regard. Those candidates who have already been admitted or take admission before 19.10.2022, 3.00 PM in a Government/Aided college/course, and if they get an allotment through this Mop Up allotment will lose the existing admission. Candidates can register options to all the courses existing in Government/Aided colleges to which the candidate wish to join as the newly vacant seats due to transfer of students who have already secured admission, will also be filled in this allotment. The options given by the candidates for previous allotments will not be considered for Online Mop up allotment. Those candidates who have not registered their options within the stipulated time will not be considered for this allotment.

The schedule for the Mop-Up allotment is given below

## 22.10.2022, 4.00 PM Last Date for joining the allotted college

Online Option Registration is mandatory in this phase. Candidates who wish to participate in the Mop up Allotment shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link "KEAM 2022 – Candidate Portal". Then by clicking the Menu item 'Option Registration', candidate can register their options online from 17.10.2022 to 19.10.2022, 10.00 AM.

The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the prospectus clause 11.7.1 before **22.10.2022, 4.00 PM** after remitting the fee as shown in the Allotment Memo, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any Head Post Offices in Kerala. The balance tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **5.00 pm on 22.10.2022**.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 6 of the Prospectus at the time of admission.

<u>Note:</u> The vacancies, if any, remaining in Engineering and Architecture courses in Government/Aided colleges after 5.00 PM on 22.10.2022 shall be filled up through further Online Mop-Up allotment, if any, by considering the same options registered by the candidates for this Online Mop Up round. Candidates should take utmost care while registering the options as no facility for re-arrangement or deletion of options will be available in the subsequent Mop Up allotments, if any.

## **Mop-up Registration Fee**

- Those candidates who wish to register options in the Mop Up allotments will have to remit registration fee of Rs.2000- (Rupees two thousand only) to the Commissioner for Entrance Examinations
- O Candidates belonging to SC/ST/OEC category and those having benefits as per GO (Ms) No.25/2005/SCSTDD dated 20.06.2005 and GO (Ms) No.10/2014/BCDD dated 23.05.2014 and those candidates from Juvenile Home are exempted from Mop Up registration fee. Candidates can register options to Mope Up allotment only after paying the applicable registration fee to the commissioner for entrance examinations.
- The registration fee once paid will not be allowed to changed at any instance. The registration fee can be paid online or through post offices to the Commissioner for

Entrance Examinations before registering options.

- For candidates who have already paid any type of fee to the Commissioner for Entrance Examinations either for registration/admission for any of the courses under KEAM 2022 will have to pay the fresh Mop Up registration fee as specified above. If such a candidate gets allotment, the registration fee will be adjusted to the course fee.
- The registration fee of those candidates who do not get allotment in the mop of allotment will be refunded.
- The registration fee of those candidates who do not join within the stipulated time after getting an allotment and those candidates who quit seats after taking admission through Mop Up allotment will be considered as penalty and will not be refunded.
