NOTIFICATION KEAM-2018 ADMISSION TO ENGINEERING/ARCHITECTURE/PHARMACY/ MEDICAL & ALLIED COURSES, KERALA APPLICATIONS INVITED

- 1. Applications are invited for admission to the following Degree Courses in various Professional Colleges in the State for the year 2018-19.
 - A. Medical Courses: (i) MBBS (ii) BDS (iii) BHMS(Homoeo) (iv) BAMS(Ayurveda) (v) BSMS (Siddha) (vi) BUMS (Unani)
 - **B. Allied Courses:**
- (i) BSc. (Hons.) Agriculture (ii) BSc. (Hons.) Forestry (iii) Veterinary (BVSc. & AH) (iv) Fisheries (BFSc.)
- C. Engineering Courses: B.Tech. [including B.Tech. (Agri. Engg.) & B.Tech. (Food Engg.&Tech.) Courses under the Kerala Agricultural University, B.Tech. (Dairy Technology) & B.Tech. (Food Technology) courses under the Kerala Veterinary & Animal Sciences University, B.Tech. (Food Technology) course under the Kerala University of Fisheries and Ocean Studies]
- D. Architecture Course: B.Arch. (No Entrance Examination. Admission is based on merit as assessed by equal weightage to NATA Score and marks/grades in the Qualifying Examination)

E. Pharmacy Course: B.Pharm.

2. Mode of Submission of Applications:- Candidates satisfying the eligibility conditions as laid down in the Prospectus and who seek admission to any or all of the above mentioned courses have to apply online through the website of the Commissioner for Entrance Examinations <u>www.cee.kerala.gov.in</u> from 1st February 2018 to 28th February 2018 and should send the printout of the online submitted application along with required supporting documents to the Commissioner for Entrance Examinations on or before the last date and time.

Note: The CEE will conduct Entrance Examination for admission to Engineering Courses only. However, candidates seeking admission to B.Pharm course shall have to appear for and qualify in Paper-I (Physics & Chemistry) of the Engineering Entrance Examination. The CEE will not conduct any Entrance Examination for admission to B.Arch. course and Medical & Allied courses. However, candidates seeking admission to B.Arch. course should compulsorily appear for and qualify in the National Aptitude Test in Architecture (NATA) conducted by the Council of Architecture (COA) on or before 10.06.2018. Candidates seeking admission to any of the Medical & Allied courses should compulsorily appear for and qualify in the National Eligibility-cum-Entrance Test-Under Graduate (NEET-UG) 2018 conducted by the Central Board of Secondary Education (CBSE). (See Clause 9.7.5 of the Prospectus)

3. Eligibility for Admission:

I. **Nativity:** Only Indian citizens are eligible for admission to Professional courses unless otherwise notified. Persons of Indian Origin (PIO)/ Overseas Citizen of India (OCI) will also be treated at par with Indian citizens for the limited purpose of admission. However PIO/OCI candidates will not be eligible for any kind of reservation.

Candidates seeking admission to Professional Degree courses will be categorised as Keralite, Non-Keralite Category I (NK I) and Non-Keralite Category II (NK II).

(A) Keralite: A candidate of Kerala origin will be categorised as a 'Keralite'. Only 'Keralite' candidates are eligible for Communal/Special/Persons with Disabilities reservation or any fee concession. Children of All India Service (AIS) officers (Non-Keralites) allotted to Kerala cadre are deemed to be 'Keralites'. But they will not be eligible for Communal/Special/ Persons with Disabilities reservation or any fee concession.

In order to prove that a candidate is an Indian Citizen of Kerala origin, he/she has to produce a <u>certificate showing that the candidate or his/her father or mother was born in</u> <u>Kerala.</u> [for details, refer clause 6.1 of the Prospectus]

- (B) **Non-Keralite Category I (NK I):** A candidate who is not of Kerala origin but fulfils anyone of the following conditions will be categorised as 'Non-Keralite Category I'(NK I).
 - (a) A candidate who has undergone qualifying course in Kerala and who is son/daughter of Non-Keralite parents belong to Government of India/Defence Service, posted to Kerala.
 - (b) A candidate who has undergone qualifying course in Kerala and who is son/daughter of Non-Keralite parents who are serving/served Government of Kerala for a minimum period of two years.
 - (c) A candidate who is not of Kerala Origin but has been a resident of Kerala State for a period of 5(five) years within the period of 12(twelve) years of his/her study.
 - (d) A candidate who is not of Kerala Origin but who has undergone his/her school studies in Kerala from standard VIII to XII.

In order to prove that the candidate is a Non-Keralite Category I (NK I), he/she has to produce the relevant proof along with the printout of the application. Non-Keralite Category I candidates will be considered against 'State Merit' seats for Engineering/ Architecture/B.Pharm/Medical & Allied courses. But they will not be eligible for Communal/ Special/Persons with Disabilities reservation or any fee concession.

(C) Non-Keralite Category II [NK II]: Candidates who do not come under 'Keralite' or 'Non-Keralite Category I' will be categorised as 'Non-Keralite Category II'. Such candidates are eligible for admission to Government seats and Management quota seats in Engineering courses in Government Controlled Self financing Colleges. However, the 'Non-Keralite Category II' (NK II) candidates will be considered for admission to the Government seats in Government Controlled Self Financing Engineering Colleges only when the Keralite and Non-Keralite I (NK I) candidates are not available for admission. 'Non-Keralite Category II' (NK II) candidates are not available for admission. 'Non-Keralite Category II' (NK II) candidates are also eligible for admission to Government Seats and Management Quota seats in Private Self Financing Engineering/Architecture Colleges. 'Non-Keralite Category II' (NK II) candidates are also eligible for admission to a maximum of 10% seats under Management Quota in Private Self Financing Pharmacy colleges. Non-Keralite Category II' (NK II) candidates will not be eligible for Communal/ Special/ Persons with Disabilities reservation or any fee concession. 'Non-Keralite Category II' (NK II) candidates are not eligible for admission to Medical and Allied Courses including MBBS/BDS and for admission to Government Engineering Colleges.

II. Academic Qualification:

(a) Medical & Allied Courses:

- (i) For MBBS, BDS, BSMS: Candidates who have passed in the subjects Physics, Chemistry and Biology/Biotechnology in the Higher Secondary examination of the Board of Higher Secondary Education, Kerala, or examinations recognised equivalent thereto, with 50% marks in Biology/Biotechnology separately, and 50% marks in Physics, Chemistry and Biology/Biotechnology put together, are eligible. In the absence of Biology, Biotechnology will be considered as a subject for academic eligibility.
- (ii) For admission to BAMS/ BHMS courses: Candidates who have passed in the subjects Physics, Chemistry and Biology in the Higher Secondary examination of the Board of Higher Secondary Education, Kerala, or examinations recognised equivalent thereto, with 50% marks in Biology separately, and 50% marks in Physics, Chemistry and Biology put together, are eligible. Biotechnology will not be considered as a subject for academic eligibility.
- (iii)For admission to BUMS course: Candidates seeking admission to main Kamil-E-Tib-Wa-Jarahat (Bachelor of Unani Medicine and Surgery-BUMS) course must have passed in the subjects Physics, Chemistry and Biology in the Intermediate (10+2) or its equivalent examination with 50% aggregate marks in the subjects of Physics, Chemistry and Biology and 50% marks in Biology separately and the candidate should have passed (a) 10th standard with Urdu or Arabic or Persian language as a subject or clear the test of Urdu in the Entrance Examination conducted by the University or Board or Registered Society authorized by the Government to conduct such examination; or (b) pre-Tib examination of one year duration.

- (iv) For admission to B.Sc.(Hons.)Agri., B.Sc.(Hons) Forestry, BFSc courses: Candidates who have passed Higher Secondary examination of the Board of Higher Secondary Education, Kerala, or examinations recognised equivalent thereto, with 50% marks in Biology separately, and 50% marks in Physics, Chemistry and Biology put together, are eligible. Biotechnology will not be considered as a subject for academic eligibility.
- (v) For admission to BVSc. & AH Course: Candidates should have secured not less than 50% aggregate marks in English, Physics, Chemistry and Biology for the qualifying examination, in addition to the condition as stipulated as above. Relaxation in marks is permissible as stipulated in clause 6.2.5 of the Prospectus for KEAM-2018.
- (vi) Eligibility of BSc. Degree holders: Candidates who have passed the BSc Degree (Three year course) examination with Physics, Chemistry, Zoology, Botany or Biotechnology as Main, and any one or two of the above subjects as Subsidiaries, with 50% marks for Main & Subsidiaries taken together, subject to the condition that they have passed Higher Secondary Examination, Kerala or examinations recognised as equivalent thereto with Physics, Chemistry and Biology as optional subjects are eligible for admission to MBBS, BDS, BAMS, BHMS and BSMS courses.
- (b) Engineering Courses:

[Including B.Tech (Agri. Engg.) and B.Tech (Food Engg. & Tech) courses under the Kerala Agricultural University, B.Tech (Dairy Technology) and B.Tech (Food Technology) courses under Kerala Veterinary & Animal Sciences University and B.Tech (Food Technology) course under Kerala University of Fisheries and Ocean Studies].

(i) Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 50% marks in Mathematics separately, and 50 % marks in Mathematics, Physics and Chemistry put together are eligible for admission. However, candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with 45% marks in Mathematics, Physics and Chemistry put together are eligible for admission under Management Quota in Private Self Financing Engineering Colleges/Government Controlled Self Financing Engineering Colleges. In case, the candidate has not studied Chemistry, the marks obtained in Computer Science shall be considered. In case, the candidate has not studied Chemistry and Computer Science, the marks obtained in Biotechnology shall be considered. In case, the candidate has not studied Chemistry, the mark list of the Board of Examination obtained from the respective Higher Secondary Board shall be considered for academic eligibility.

Note:- (a) In two year Kerala Higher Secondary courses or examinations recognised equivalent thereto with two year course where the Board Examinations are conducted in both years, the total marks of two years in the respective subjects as shown in the mark lists of the respective Higher Secondary Boards will be considered for academic eligibility.

(b) In Higher Secondary courses or examinations recognised equivalent thereto where Board Examinations are conducted only at the end of 12th class (final year), the marks in the respective subjects as shown in the mark lists of the respective Higher Secondary Boards will be considered for academic eligibility.

(c) For all other type of Higher Secondary courses or examinations recognised equivalent thereto, the marks of the respective subjects as shown in the mark list of the respective Board of Examinations will be considered for academic eligibility.

(ii) Candidates who have passed Higher Secondary Examination, Kerala, or examinations recognised as equivalent thereto, with 50 % marks in Mathematics/Biology separately, and 50 % marks in Physics, Chemistry and Mathematics/Biology put together are eligible for admission to the seats reserved for Dairy Farm Instructors of Dairy Development Department for B.Tech. (Dairy Technology). However, the candidates admitted to the course have to take a make-up course in Basic Mathematics (2+0) credits or Applied Biology (1+1) credit as the case may be.

The Vocational Higher Secondary Examination, Kerala, has been recognised as equivalent to the Higher Secondary Examination, Kerala.

(c) Architecture Course:

(i) Minimum academic eligibility for admission to B. Arch.:

10+2 or equivalent examination from a recognised Board with Mathematics as a subject of study by securing 50% marks in aggregate **OR** 10+3 Diploma (any stream) recognised by Central/State Governments with 50% aggregate marks with Mathematics as one of the subject of examination **OR** International Baccalaureate Diploma, after 10 years of schooling, with not less than 50% marks in aggregate and with Mathematics as compulsory subject of examination.

(ii) In addition to the academic eligibility as above, only those candidates who score the minimum eligibility marks as per the Information Brochure of National Aptitude Test in Architecture (NATA) 2018 will be considered for admission to B. Arch. course. <u>There is</u> no relaxation in the minimum passing score of NATA to any category of candidates. The candidates shall have to gualify in NATA on or before 10.06.2018.

(d) B.Pharm Course:

Candidates who have passed Higher Secondary Examination, Kerala or Examinations recognized as equivalent thereto, with 50% marks in Biology/Mathematics separately and 50% marks in Physics, Chemistry and Biology/ Mathematics put together are eligible.

III. Relaxation in marks:

For all the courses, candidates belonging to Socially and Educationally Backward Classes will have a relaxation of 5% marks in the qualifying examination. They need only 45% marks in the case of Mathematics/Biology and 45% marks in the case of Mathematics/Biology, Physics and Chemistry put together. The Scheduled Castes and Scheduled Tribes candidates need only a pass in the qualifying examination. However, for admission to MBBS/BDS courses, candidates belonging to SC/ST categories need 40% marks in Physics, Chemistry and Biology/Biotechnology put together in the qualifying examination. Candidates with Locomotory disability of lower limbs between 40% to 70% need only 45% marks in case of Biology/Biotechnology and 45% marks in case of optional subjects put together for admission to MBBS/BDS courses (as per the Guidelines of Medical Council of India/Dental Council of India). The candidates belonging to PD category will have a relaxation of 5 % marks in the qualifying examination for Engineering and Medical Allied Courses. They need only 45 % marks in the case of Mathematics/Biology and 45 % marks in the case of Mathematics/Biology, Physics and Chemistry put together. Provided that in cases where only grades are given for qualifying examination and marks are not mentioned, the grade covering 45% marks will be considered as criterion for eligibility. The relaxation in marks in the Qualifying Examinations available to SEBC and PD Candidates will not be applicable to the admissions under Management Quota in Private Self Financing Engineering Colleges/Government Controlled Self Financing Engineering Colleges.

The relaxation of marks in the qualifying examination extended to SEBC candidates only will be applicable to OEC candidates even if they are allotted against the unavailed seats of SC/ST quota..

- IV. Age: Applicants should have completed 17 years of age as on the 31st December 2018. No relaxation in the minimum age will be allowed. There is no upper age limit for Engineering, Architecture and B.Pharm Courses. For Medical and Allied courses, the upper age limit will be as per the Information Bulletin of NEET(UG)-2018. Candidates should attach proof for their date of birth along with the printout of application.
- 4. Schedule of the Engineering Entrance Examination: The Engineering Entrance Examination will be held at all the District Centres in Kerala and in New Delhi, Mumbai and Dubai (UAE), on the dates mentioned below as per Indian Standard Time (IST).

<u>Note</u>: Candidates applying for admission to B.Pharm Course shall have to write Paper-I (Physics & Chemistry) of the Engineering Entrance Examination.

5. Application Fee:

ST candidates are exempted from payment of application fee.

(a) Candidates can remit the application fee in either of the two following methods:

- (i) Online Payment: The fee may be paid by credit card/debit card/Internet Banking. On successful payment of fee, a Payment Confirmation Page will appear displaying the message 'Transaction Successful'. If the payment is unsuccessful, the message 'Transaction Unsuccessful' will be displayed. Due to communication failure, if the outcome of the payment attempt is not displayed, the 'Payment' tab in the candidate's home page should be checked to see if it has turned green. If not, the transaction was unsuccessful and the payment needs to be made again and ensure that it's successful. If the amount was debited from the account of the candidate for an unsuccessful transaction, the debited amount will be reverted to that account within 5-7 working days.
- (ii) E-chalan: In case of payment through e-chalan, the payment should be made in all Head /Sub Post Offices in Kerala, in cash. The e-chalan generated from the website after online submission of the application should be handed over to the post office and after depositing the fee plus processing charge, as applicable, the counterfoil (Candidate's copy) of the e-chalan must be collected back from the post office official. It must be ensured that the post office official has recorded the Payment ID pertaining to the payment on the counterfoil and put the office stamp and his/her initials at the designated places on the counterfoil. If the payment was successful, the 'Payment' tab in the candidate's home page turns green. Candidates are advised to login to the website and examine the 'Payment' tab to make sure that the fee status has been updated by the post office official. If the payment tab has not turned green, the candidate should immediately contact the concerned post office and get the payment status updated.

On successful Payment, the required entries in the application will be made automatically. **Note**: The Application fee/additional fee once remitted will not be refunded under any circumstances.

(b) Candidates opting Dubai (UAE) as the Centre for Entrance Examination: Candidates choosing 'Dubai' as Examination Centre will have to remit an additional fee of Rs.12,000/- by way of online payment. The additional fee can also be remitted by way of e-chalan, if payment is made inside Kerala. (See clause 7.3.1 for more details) Such candidates should give a local contact number, if available, in their application in the appropriate place. If the additional fee of Rs. 12,000/- is not paid by the candidates, they will be allotted a centre within the country.

6. Last date and time for receipt of the Printout of the Application:

The Printout of the Application and other relevant documents, to be submitted with the Application, are to be enclosed and sent in an A4 sized envelope, so as to reach Office of the <u>Commissioner for Entrance Examinations</u>, 5th <u>Floor, Housing Board Buildings</u>, <u>Santhi Nagar, Thiruvananthapuram-695001</u> before 5 p.m. on 31.03.2018 (Saturday), by Hand Delivery/Registered Post/Speed Post. Completed Applications will be received in the Office of the Commissioner for Entrance Examinations on holidays also.

- **7.** Belated Applications: Belated applications will be rejected. Candidates are therefore advised to submit the application along with the supporting documents well in advance. The Commissioner for Entrance Examinations will not be responsible for any postal delay.
- 8. Nativity Proof & Course Certificate: All the applicants should attach the proof for Nativity (See Prospectus Clause 6.1) along with the printout of application. Candidates who have selected Medical courses and have studied Sanskrit at +2 level should attach Original Course Certificate/copy of mark list (as applicable) along with the printout of the application. The Course Certificate is to be obtained in the prescribed format available along with the printout of Application.

- 9. Other Certificates/Documents to be submitted along with the printout of application for Communal/Special/Persons with Disability reservations and other benefits;
- a) Candidates claiming reservation under Socially and Educationally Backward Classes (SEBC) and other Eligible Communities (OEC) should submit the original Non-Creamy Layer Certificate obtained from the Village Officer. Those OEC candidates who do not come under Non-Creamy Layer Category should submit the original Community Certificate obtained from the Village officer for availing the Fee concession.
- b) Candidates claiming reservation under Scheduled Castes (SC) and Scheduled Tribes (ST) should submit the original Community Certificate obtained from the Tahsildar.
- c) Candidates belonging to Communities listed in Annexure X(a) of the Prospectus who are eligible for educational concessions as is given to OEC should submit the original Community and Income Certificates from the Village Officer. But those who have submitted Non-Creamy Layer Certificate for claiming the applicable reservation need to submit the Income Certificate only for availing the fee concession.
- d) Candidates who are children of Inter-Caste married couples of whom one is SC/ST will be eligible for educational and monetary benefits admissible to SC/ST. Such candidates should produce the original Inter-Caste marriage Certificate from the Tahsildar. If they are eligible for reservation under SEBC, the Non-Creamy Layer certificate obtained from the village officer is to be submitted along with the printout of application for availing SEBC reservation.
- e) Candidates seeking Special Reservation as per Clause 5.2 of the Prospectus should submit the required documents mentioned therein.
- f) Candidates seeking reservation under Persons with Disabilities (PD) should submit a self attested copy of the certificate of disability from the District Medical Board certifying the percentage of degree of disability, along with the printout of the application (see Prospectus clause 5.3)
- g) Candidates (except SC/ST/OEC) including General category who are desirous of being considered for any fee concession/scholarship/any other benefits based on annual family income should produce the original Income Certificate obtained from the Village officer along with the printout of the application.
- **10**. Incomplete or defective applications will be summarily **REJECTED** and no correspondence will be entertained in this regard.
- 11. Admit Card: The Admit Cards for the Engineering Entrance Examination can be downloaded from the website <u>www.cee.kerala.gov.in</u> from 10.04.2018. The printout of the admit card thus obtained will have to be produced at the time of examination. Admit Cards will not be sent by post from this office to the candidate.
- 12. The Engineering Entrance Examination and the allotments/admissions to all the courses will be based on the various provisions laid down in the Prospectus approved by the Government. Prospectus for KEAM 2018 is available on the website of the Commissioner for Entrance Examinations, <u>www.cee-kerala.org</u> and <u>www.cee.kerala.gov.in</u>. Candidates are requested to go through the various provisions in the Prospectus before submitting their applications.
 - * Candidates should frequently visit the above websites of the Commissioner for Entrance Examinations for authentic information with regard to Entrance Examination/allotments/ admissions and related matters.

Candidates who do not have access to Internet facility can use the facility provided free of cost at the Facilitation Centres across the State. The list of Facilitation Centres will be published in the website. Necessary facilities have been provided in all the Govt/Aided Higher Secondary and Vocational Higher Secondary Schools in the State to help the students for Online Submission of Applications.
