ADMISSION TO PG DENTAL COURSES (MDS) 2021

Second Round of Stray vacancy filling at Institutional level following the lowering of NEET MDS 2021 cut off scores

As the NEET-MDS-2021 minimum qualifying percentile has been lowered by the National Board of Examinations as per the Letter no. V.12025/154/2021/-DE, dated 10th November 2021, MoHFW, the Commissioner for Entrance Examinations, has invited new applications from the newly qualified candidates from 13.11.2021 to 16.11.2021, 1.00 pm. Based on the application submitted by the newly qualified candidates, a supplementary rank list has been prepared by the Commissioner for Entrance examinations, to fill up the vacancies existing after the first round of Stray vacancy filling at Institution level for admission to PG Dental Course 2021.

In order to fill vacant seats remaining after the first round of stray vacancy filling at Institutional level, Commissioner for Entrance Examinations has prepared the list by including the candidates satisfying the following criteria.

- a. The candidate is not presently admitted in a Dental college for MDS course-2021, nor should he/she allotted a seat in the mop-up counselling (state or all India) irrespective of admission status.
- b. The candidate figures in the supplementary rank list prepared by the CEE based on the applications from candidates following the lowering of cut-off scores of NEET-MDS-2021.
- c. The candidate should have registered options for seats in colleges where vacancies exist, through the option registration facility which was available on the website of CEE from 13.11.2021 to 16.11.2021, 1.00 PM.

The supplementary rank list, probable list of candidates, vacancy list and guidelines for the allotment procedure are published in the website of Commissioner for Entrance Examinations www.cee.kerala.gov.in. Eligible Candidates can contact the Colleges concerned and report at the college on or before 18.11.2021, 3.00 PM, with all required documents to participate in the allotment process. Based on the guidelines and the lists of candidates issued by the Commissioner for Entrance Examinations, Colleges can conduct the admission process till 18.11.2021, 5.00 PM. If any vacancy exists even after this stage, colleges can start the next process stage of the vacancy filling procedure as stated in the guidelines till the last date for admission to MDS 2021, fixed by the DCI.

Those candidates who have been issued memo in candidate portal in connection with basic eligibility (such as nativity, birth proof) and/or a benefit claim (such as fee concession, lower cut off) should clear the memo by uploading document concerned on or before 17.11.2021, 3.00 pm, failing which the candidature or the benefit claim, as the case may be, will be cancelled. College authorities should report the details of Stray vacancy filling and remaining vacancy if any, through OAMS on or before 18.11.2021 5.00 pm to the Commissioner for Entrance Examinations, and that of the final round on 20/11/2021, 5 pm.
