## ONLINE MOP-UP COUNSELING TO FILL UP THE VACANT SEATS IN ENGINEERING/ARCHITECTURE/PHARMACY COURSES OPTIONS INVITED

The activities related to the online allotment to fill the up vacant seats Engineering/Architecture/Pharmacy courses in Government/Aided/ Government Controlled Engineering colleges, namely Sree Chitra Thirunal College of Engineering, Pappanamcode, Thiruvananthapuram, University College of Engineering, Thodupuzha, Idukky, Calicut University Institute of Engineering and Technology, Tenhipalam, Malappuram, Govt. Architecture College, Govt. Pharmacy College commenced on 31.07.2019. Candidates included in the rank lists for Engineering/Architecture/Pharmacy Courses 2019 published by CEE alone can give Online Options. The allotment based on the Online Option existing up to 5.00 PM on 04.08.2019 will be published in the evening on 05.08.2019.

## DETAILED SCHEDULE FOR THE ALLOTMENT

31.07.2019	Website opens for Online Option Registration starts.
04.08.2019, 5.00 PM	Time for Online Option Registration ends
05.08.2019, 4.00 pm	Publication of Allotment
06.08.2019 to 08.08.2019, 4.00 pm	Candidates who receive allotment should remit the fee/balance fee (if applicable) payable to CEE in any of the Head Post Offices in Kerala or by way of online payment.
08.08.2019 (5 pm)	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS).

The candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/balance fee(if applicable) payable to the Commissioner for Entrance Examinations in any of the Head Post Offices in Kerala or by way of Online payment and should join the College/Course allotted. The list of Post Offices having facility for fee payment is available in the website.

There is a possibility of arising new vacancies in other courses/seats when the existing vacancies are filled. So the candidates must register all courses needed by them at the time of Option Registration. The vacancy arising after the Online Mop-Up counselling in Engineering/Architecture Courses will be filled by the Director of Technical Education though Spot Admission.

## **Token Deposit:**

Candidates getting allotment afresh who belong to SC/ST/OEC/Children of Registered Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have no token deposit to the Commissioner for Entrance Examinations. They should join the college allotted before 5 pm on 08/08/2019.

Those candidates who do not remit the fee/balance fee (if applicable) and do not join the college allotted within the stipulated time will lose their allotment. Candidates register their option only to the College/Courses in which they wishes to join.
