INTEGRATED FIVE YEAR LL.B COURSE, 2019-20 ONLINE ALLOTMENT (MOP-UP) TO FILL UP THE VACANT SEATS PUBLISHED

The Online Allotment for filling up the vacant seats in Integrated Five Year LL.B Courses in the 4 Government Law Colleges and Private Self Financing Law Colleges in the State which have entered into seat sharing agreement with the Government for the year 2019-20 is published herewith in the website <u>www.cee.kerala.gov.in</u>. The allotment is based on the fresh online options registered by the candidates through the above website for this vacancy filling allotment.

Candidates can access their homepage by entering their Application number, and Password in the 'Integrated Five Year LL.B 2019 - Candidate Portal' provided in the above website and by clicking the menu item 'Allotment Result', they can download their Allotment Memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit if any etc. are available in the Allotment Memo. Candidates shall have to take a print out of the Allotment memo. Candidates can also log into their Home Page and click the Menu Item 'Data Sheet' for downloading the Data Sheet.

Candidates who receive fresh allotment or a change in allotment than the previous phase shall have to take a printout of the Allotment memo and remit the fee, if any, to be paid to the Commissioner for Entrance Examinations by way of **Online Payment** or at any of the selected **Head Post Offices in Kerala** and should report for admission before the Principal of the allotted colleges on any date from **20.08.2019** to **26.08.2019**, **4 pm (excluding holidays)** along with the Allotment memo and original documents specified in Clause **18** of the Prospectus. They should remit the balance fees, if any, as per Government orders, in the allotted college at the time of admission. The candidates who do not join the college within the stipulated time will lose their allotment.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **5 pm on 26.08.2019.**

<u>Note</u>:- Candidates who receive a change in allotment in this vacancy filling phase of allotment will automatically lose their admission in the previous phase and they should obtain the T.C, relevant documents and amount remitted at the time of admission from their currently admitted college and should join the newly allotted college within the stipulated time.
