ADMISSION TO POST GRADUATE DIPLOMA COURSE/ 15% DEGREE ALL INDIA QUOTA SEATS IN SELF FINANCING COLLEGES IN AYURVEDA, KERALA 2021 Fresh Applications Invited

Applications are invited for admission to

- 1. Post Graduate Diploma Courses in Ayurveda in Government and Government Aided Ayurveda Colleges.
- 2. 15% of P G Ayurveda Degree seats in self-financing colleges of the state (All India Quota), set apart for the allotment of candidates irrespective of their domicile.

Note: Candidates who have already applied for PG Ayurveda Courses-2021 vide this office Notification dated 24.01.2021 and included in the state PG Ayurveda Rank list need not apply again. They will be considered for the above seats also, if interested, based on the rank list for the PG Diploma courses in Government and Government Aided Ayurveda Colleges and the 15% All India Quota seats in Self Financing Colleges, to be prepared by the CEE. The new rank list will be prepared based on the AYUSH PGET-2021 All India rank and will include all the candidates from the Kerala State PG Ayurveda rank list 2021 and the eligible candidates among the new applicants. The new rank list will be confined to allotments to the newly included seats only. Therefore, the new applicants will not be eligible for any seats other than the PG Diploma seats in Government and Government Aided Ayurveda Colleges and the 15% All India Quota seats in Self Financing Colleges. Furthermore, Non-Keralite candidates will be eligible to be considered only for the 15% All India Quota seats in Self-Financing Ayurveda Colleges of the state, set apart for the allotment of candidates irrespective of their domicile.

Eligibility for admission:

i. Nativity:

- a. Applicant should be an Indian Citizen of Kerala origin to be considered for admission to PG Ayurveda Diploma Courses in various Ayurveda Colleges of the state.
- b. Both Keralite and Non-Keralite Indian Citizens can apply for admission to All India Quota Seats in Self Financing Colleges.
- **ii. Age**: Candidate should not be over 45 years of age as on 31.07.2021, subject to a relaxation of five years in the case of SC/ST candidates.
- **iii. Qualifying Criteria**: All candidates seeking admission to Postgraduate Degree/Diploma Ayurveda courses in the State of Kerala for the academic year 2021-22 should have qualified the National Eligibility Cum Entrance Test for PG (Ay) Courses (AYUSH PGET-2021) conducted by AIIA, New Delhi and should be included in the rank list prepared by the Commissioner for Entrance Examinations.

	The cut-off percentile and score for PwD candidates belonging to SC/ST/SEBC categories are 40 and 87 respectively.	

iv. Academic Qualifications

Candidates should have passed BAM /Ayurvedacharya /BAMS from the colleges having CCIM recognition and BAMS Degree of Universities of Kerala or its equivalent degree recognized by the Kerala University of Health Sciences (KUHS) with 50% of marks for theory and practical separately in each subject. But exemption for minimum marks prescribed for admission for MD (Ay)/MS

(Ay) is granted to the students who have passed the BAMS/BAM examination before 1995 from the Universities of Kerala without 50% of marks for theory and practical. The cut-off date for completion of internship towards determination of eligibility for admission is 31.12.2021 subject to the production of an Internship Certificate from the Medical Council constituted in this regard.

Mode of selection:

The Commissioner for Entrance Examination will prepare a rank list exclusively for the PG Diploma courses in Government and Government Aided Ayurveda Colleges and the 15% All India Quota seats in Self Financing Colleges, and the selection shall be made from the rank list subject to the eligibility criteria stated in the prospectus.

Submission of Application

Fresh Applicants for admission to the PG Diploma courses in Government and Government Aided Ayurveda Colleges and the 15% All India Quota seats in Self Financing Colleges may apply Online from 19.02.2021 onwards, through the website www.cee.kerala.gov.in of the Commissioner for Entrance Examinations by entering relevant AIAPGET 2021 details followed by filling and submitting the online application. Thereafter, the candidates should remit the required fee by online payment or by payment at the Head Post Offices/Sub Post Offices in Kerala using the e-chalan generated from the Online Application Portal. The online payment facility and e-chalan for payment at the Head/Sub Post Offices in Kerala are available at the Online Application Portal. After remitting the required application fee, candidates have to upload their photo and signature and all the necessary Certificates / Documents, through the Online Application Portal.

benefits, after the submission of the application.

The nativity/community/category claims made by the candidates in the online

application will be rejected, if the required documents are not uploaded to the

online application within the stipulated time.
