KEAM 2022 ONLINE MOP UP ALLOTMENT TO VACANT SEAT IN PRIVATE SELF FINANCING ARCHITECTURE COLLEGES-2022 CANDIDATES CAN REGISTER NEW OPTIONS

The activities related to the Mop Up Allotment for admission to the vacant seats in Architecture Course in the Private Self Financing Architecture colleges will commence on 21.10.2022. The Mop-Up allotment is conducted for filling the vacancy existing in Architecture colleges as per G.O.No(MS)No.1537/2022/HEDN dated 19.10.2022. Candidates who have figured in the Architecture rank list published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per Clause 6 in the KEAM 2022 Prospectus can participate in the Mop Up allotment. However the allotment/admission of those candidates who have already taken an admission in any of the Private Self-financing Engineering colleges will be subject to the orders of the Government in this regard. Those candidates who have already been admitted in a Government/Aided college/course, and those who got an allotment as per the Notification dated 20.10.2022 are not included in this Mop Up round. Candidates can register options to B.Arch couse in all Self Financing Architecture colleges to which the candidate wish to join as the newly vacant seats due to transfer of students who have already secured admission, will also be filled in this allotment. The options given by the candidates for previous allotments will not be considered for this Online Mop up allotment. Those candidates who have not registered their options within the stipulated time will not be considered for this allotment.

The schedule for the Mop-Up allotment is given below

21.10.2022	Website opens for New Options Registration
23.10.2022, 11.00 AM	Time for Option registration ends
25.10.2022	Mop Up Allotment
27.10.2022, 4.00 PM	Last Date for joining the allotted college

Candidates who wish to participate in the Mop up Allotment shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link "KEAM 2022 – Candidate Portal". Then by clicking the Menu item 'Option Registration', candidate can register their options online from 21.10.2022 to 23.10.2022, 11.00 AM

The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the prospectus clause 11.7.1 before **27.10.2022**, **4.00 PM** after remitting the fee as shown in the Allotment Memo, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any Head Post Offices in Kerala. The balance tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **5.00 pm on 27.10.2022**.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 6 of the Prospectus at the time of admission.

Note: The vacancies, if any, remaining in Architecture course in Private Self-financing Architecture colleges after 5.00 PM on 27.10.2022 shall be filled up through further Online Mop-Up allotment, if any, by considering the same options registered by the candidates for this Online Mop Up round. Candidates should take utmost care while registering the options as no facility for re-arrangement or deletion of options will be available in the subsequent Mop Up allotments, if any.

Mop up Registration Fee

- Those candidates who wish to register options in the Mop Up allotments will have to remit registration fee of Rs.2000- (Rupees two thousand only) to the Commissioner for Entrance Examinations. The registration fee once paid will not be allowed to change at any instance. The registration fee can be paid online or through Head Post Offices to the Commissioner for Entrance Examinations before registering options. Candidates belonging to SC/ST/OEC category and those having benefits as per GO (Ms) No.25/2005/SCSTDD dated 20.06.2005 and GO (Ms) No.10/2014/BCDD dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chithra Home are exempted from Mop Up registration fee. Candidates can register options to Mop Up allotment only after paying the applicable registration fee to the Commissioner for Entrance Examinations.
- For candidates who have already paid any type of fee to the Commissioner for Entrance Examinations either for registration/admission for any of the courses under KEAM 2022 will have to pay the fresh Mop Up registration fee as specified above. If such a candidate gets allotment, the registration fee will be adjusted to the course fee.
- The registration fee of those candidates who do not get allotment in the mop of allotment will be refunded later.

through Mop Up allotment will be considered as penalty and will not be refunded.
