## ADMISSION TO INTEGRATED 5 YEAR LL.B COURSE, 2019-20

## FIRST PHASE OF ALLOTMENT PUBLISHED

The first phase of Centralised Allotment for admission to Integrated Five year LL.B Courses in the 4 Government Law Colleges and Private Self Financing Law Colleges in the State for the year 2019-20 is published herewith on the website **www.cee.kerala.gov.in.** The allotment is based on the online options registered by the candidates up to 1 pm on 18.07.2019.

Candidates can access their homepage by entering their Application Number, and Password in the 'Integrated Five Year LL.B 2019 - Candidate Portal' provided in the above website. Then by clicking the menu item 'Allotment Result' candidates can download their Allotment Memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit if any etc. are available in the Allotment Memo. Candidates can also click the Menu Item 'Data Sheet' in the home page for downloading the Data Sheet.

Candidates who receive allotment shall have to take a print out of the Allotment memo and remit the fee to be paid to the Commissioner for Entrance Examinations by way of Online Payment or at any of the selected Head/Sub Post Offices and should report for admission before the Principal of the allotted colleges on any date from 19.07.2019 to 22.07.2019, 4 pm (excluding Sunday) along with the Allotment memo and original documents specified in Clause 18 of the Prospectus [For details, see notification dated 12.07.2019]. They should remit the balance fees as per Government orders in the allotted college at the time of admission.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **5 pm on 22.07.2019.** 

The candidates who do not join the college within the stipulated time will lose their present allotment and also their higher order options. Also such candidates will not be considered for further Online allotments.

**Important**: The activities related to the second phase of allotment to 5 year LL.B course will commence on 20.07.2019. Candidates who have received an admission in the first phase and who want to be considered for the second phase shall have to perform **online option confirmation**. Similarly, candidates who have not received any allotment in the first phase shall have to perform online option confirmation invariably for being considered in the second phase. Facility for Online Option Confirmation and rearrangement/deletion of higher options will be available from 20.07.2019 to 23.07.2019, 5 pm in the above website. The second phase of allotment shall be published on 24.07.2019.
