#### **SPOT ADMISSION TO THE BDS VACANT SEATS**

The vacancies available after the Mop-Up Counselling for BDS Course is filled through a spot admission on **30.08.2019, 2 pm** at **Travancore International Convention Centre of Kariavattom Sports Hub, Thiruvananthapuram (Green field Stadium)**. The candidates who are included in the Kerala State medical rank list published by the CEE, alone can participate in the Spot admission. Candidates who have already been admitted in BDS Course in Private Self Financing colleges as per the previous allotments will not be permitted to claim the vacancy of another Self Financing college.

Candidates who wish to participate in the spot admission must register by visiting the home page of the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) and download the slip by clicking in the link '**Registration slip**' available in the candidate portal from 28.08.2019, 6.00 pm onwards. The registration slip is essential for participating in the admission process. The vacancies (including Govt. colleges) which will be released upto 30.08.2019, and the existing vacancies in state merit (44) will be filled through the spot admission.

#### **DETAILS OF FEE & MODE OF REMITTANCE**

Candidates getting allotment during the spot admission shall have to remit the fee of Rs.1,00,000/- by way of demand draft drawn from a Nationalized/ Scheduled bank in favour of the Commissioner of Entrance Examinations payable at Thiruvananthapuram. Candidates those who have remitted any fee amount to the Commissioner for Entrance Examinations as per the KEAM allotments (Except Engineering/Architecture/Pharmacy) need to submit the Demand Draft for the balance amount only. Candidates getting allotment to BDS course who belong to SC/ST/OEC and other eligible candidates for fee concession are exempted from payment. For more details regarding fee, see the notification at the time of option registration.

#### **DOCUMENTS TO BE SUBMITTED AT THE TIME OF SPOT ADMISSION**

Candidates who wish to participate in the Spot admission shall appear in person with the following documents.

- 1) Registration Slip
- 2) Demand Draft for the requisite amount
- 3) The candidates who got an admission in any course/college (Except Engineering/Architecture/Pharmacy) as per the previous allotment conducted by the Commissioner of Entrance Examinations should produce NOC, Possession Certificate (in original) & the copy of the eligibility certificate (prospectus clause 11.7.1) and the amount of DD mentioned above.
- 4) Other candidates can participate only with TC and originals of the uploaded certificates, (prospectus clause 11.7.1) along with the amount of DD mentioned above.
- 5) Eligibility certificate from any University in Kerala, in the case of candidates who have passed a qualifying examination other than Higher Secondary Examination/Vocational Higher Secondary Examination conducted by Government of Kerala or the examination conducted by CBSE and CISCE.
- 6) Migration Certificate, if applicable.
- 7) Certificate to prove date of birth.
- 8) Data sheet of KEAM 2019.
- 9) Physical Fitness Certificate in the relevant format given in Annexure XVII (b) of the Prospectus 2019.

#### **NOTE:-**

Candidates who cancel their admission after getting allotment in Spot admission will have to pay liquidated damages as stipulated in Clause 12.2.4.
