ENGINEERING/ARCHITECTURE/PHARMACY & MEDICAL ALLIED COURSES EXCLUDING
M.B.B.S/B.D.S - ONLINE OPTIONS INVITED

The activities related to the third phase of allotment to Engineering, Architecture and Pharmacy Courses and second phase of allotment to Medical Allied Courses (Except M.B.B.S/B.D.S courses) began on **12.07.2019**. In this phase, allotment will be done to the newly included courses of Ayurveda, Homoeo, Siddha & Unani.

Online Option Confirmation is mandatory for Engineering/ Architecture/ Pharmacy Courses & Agriculture/Veterinary/Forestry/Fisheries courses:

The Candidates who want their higher order options in Engineering, Architecture and Pharmacy courses to be considered in the third phase of allotment and Agriculture/Veterinary/Forestry/Fisheries courses in the second phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges if applicable, from **12.07.2019** to **16.07.2019, 1.00 pm**, through the website www.cee.kerala.gov.in. On the basis of options received up to **01.00 pm** on **16.07.2019**, the third phase allotment to Engineering, Architecture and Pharmacy courses and second phase allotment to Agriculture, Veterinary, Forestry and Fisheries courses and first phase allotment to Ayurveda/Homoeo/Siddha/Unani Courses will be published in the evening on **17.07.2019**. Candidates who receive allotment in Engineering, Architecture and Pharmacy Courses in this phase shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations, at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **18.07.2019** to **20.07.2019, 4 pm**. The list of Post Offices having facility for fee payment is available in the website. After remitting the fee/balance fee, the candidates should join the course/college allotted before **4 pm** on **20.07.2019**.

Candidates who receive allotment in Medical Allied Courses (Excluding M.B.B.S/B.D.S) in this phase shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations, at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **18.07.2019** to **22.07.2019, 4 pm**. The list of Post Offices having facility for fee payment is available in the website. After remitting the fee/balance fee, the candidates should join the course/college allotted before **4 pm** on **22.07.2019**

Online option confirmation is a must for those who got admission and those who got **no** allotment as per the second phase allotment, to consider them in the third phase allotment in the case of Engineering/ Architecture/Pharmacy courses. But those who do not confirm options after admission, the same shall be retained. Similarly, those who got admission and those who got **no** allotment as per the first phase allotment for Agriculture/ Veterinary/ Forestry/ Fisheries courses, online option confirmation is must for second phase allotment. But those who do not confirm options after admission, the same shall be retained. Online Option Confirmation is mandatory for being considered in this phase of allotment for both candidates admitted with a course in the first phase/second phase respectively and those who have not received any allotment in the first phase/second phase respectively including SC/ST/OEC and other candidates eligible for fee concession.

FEES:

The details of fee for the Engineering, Architecture, Pharmacy, Medical & allied courses, in various colleges is available in the website. Fee structure in the case of Self Financing Ayurveda/Sidha/Unani colleges is subject to change as decide by the AFRC in due course.

Token Deposit :

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have no token deposit.

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies, Affiliation from the Universities and Government Orders.

The third phase of allotment will be the last phase of allotment to Private Self Financing Engineering/Architecture/Pharmacy colleges. The availability of higher options to the students allotted to Private Self Financing Engineering and Architecture/Pharmacy colleges shall be as per the Government orders. Hence all the candidates are instructed to go through and satisfy themselves regarding the conditions in the above Government Orders.

Note:

- 1) Candidates are advised to file options to the courses/colleges to which they are sure to join and continue studies if allotted, at the time of registration of options.
- 2) The candidates whose results in the respective rank lists have been withheld due to various reasons can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they produce the required documents to clear the defects and release their ranks before 5 pm on 15.07.2019
