**ALLOTMENT PUBLISHED**

The allotment to Engineering, Architecture, Pharmacy, Agriculture, Veterinary, Forestry, Fisheries, Ayurveda, Homoeo, Siddha and Unani Courses-2019 is published on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). This is the last phase of allotment to Self Financing Engineering/Architecture/ Pharmacy colleges. The Notification for second phase allotment to MBBS,BDS Courses will be published subsequently. In this phase of allotment, Vaidyaretnam Ayurveda College, Thaikkattussery, Ollur (OLR), Ahalia Ayurveda Medical College, Elippara, Palakkad (AHA), MVR Ayurveda Medical College, Parassinikadavu, Kannur(PRK), Santhigiri Ayurveda Medical College, Palakkad (SGA) were exempted from allotment as they have not received the affiliation orders from the Ministry of Ayush and concerned University. These colleges will be considered for further allotment if they produce the concerned orders later.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate and also in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment afresh and who get a change in allotment than that of the previous allotment should remit the fees (if any) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **18.07.2019 to 20.07.2019** for Engineering, Architecture and Pharmacy courses and should join the course/college allotted before **4 pm on 20.07.2019**.

For Agriculture, Veterinary, Forestry, Fisheries, Ayurveda, Homoeo, Siddha, Unani courses candidates who receive an allotment afresh and who get a change in allotment than that of the previous allotment should remit the fees (if any) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **18.07.2019 to 22.07.2019** and should join the course/college allotted before **4 pm on 22.07.2019**. The list of Post Offices having facility for fee payment is available in the website.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission.

**Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.**

**Important:**

- 1) Candidates admitted to the Private Self Financing Engineering colleges after the third phase of allotment shall not be considered in the further online allotments (if any) to Engineering courses as per the relevant Government orders subsequently.
- 2) Candidates admitted to the Private Self Financing Architecture colleges after the third phase of allotment shall not be considered in the further online allotments (if any) to Architecture course as per the relevant Government orders subsequently.
- 3) Candidates admitted to the Private Self Financing Pharmacy colleges after the third phase of allotment shall not be considered in the further online allotments (if any) to Pharmacy course as per the relevant Government orders subsequently.
