**ADMISSION TO MBBS/BDS/AGRICULTURE/FORESTRY/FISHERIES/ VETARINARY/
AYURVEDA/HOMOEOPATHY COURSES**
CENTRALISED ALLOTMENT PUBLISHED

The second phase of allotment to MBBS/BDS/Agriculture/ Veterinary/Forestry /Fisheries and First phase of allotment to Ayurveda/Homoeo Courses-2020 is published on the website www.cee.kerala.gov.in. Karuna Medical college Palakkad, SUT Academy of Medical Sciences Thiruvananthapuram are newly included in this phase of allotment and additional intake of 50 seats in Dr. Somervell Memorial CSI Medical College, Karakonam, Thiruvananthapuram . The allotment is based on the online options filed by the candidates up to 11 am on 09.12.2020 through the above website. Candidates included in the list furnished by Ministry of Health and Family Welfare Government of Indian as admitted under all India Quota MBBS/BDS such have not seen considered for the second phase of allotment to Medial & Medical Allied course courses in this state.

The details of allotment of a candidate such as **Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details** etc. will be available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **11.12.2020 to 16.12.2020** and should join the course/college allotted before **4 pm on 16.12.2020**. The list of Post Offices having facility for fee payment is available in the website.

The candidates who get a change in allotment other than that of the first allotment should pay the balance fee, if applicable, in any **Head Post Office in Kerala** or by way of **Online Payment** on any date from **11.12.2020 to 16.12.2020** and should join the course/college allotted as per the second phase allotment memo before **4 pm on 16.12.2020**.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra home, Juvenile home, Nirbhaya home need not remit token deposit to the Commissioner for Entrance Examinations. However if they are allotted seat under Minority/NRI quota in Self-financing Medical/Dental colleges they will have to remit the token fee prescribed to CEE and they will not be eligible for fee concession.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission.

Thus all the candidates who have an allotment should join the course/college as per the allotment before 4 pm on 16.12.2020.

Those candidates who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.

Allotment to vacant MBBS, BDS course that may arise after second phase of centralized allotment shall be filled through a Mop Up counselling to be conducted by the Commissioner for Entrance Examinations, detailed notification of Mop Up counselling will be published later.
