ONLINE MOP UP COUNSELLING TO MBBS COURSE

FACILITY TO REGISTER ONLINE OPTIONS

Vacancies in MBBS course that may arise in various Government/Self Financing Colleges after the second phase of allotment will be filled through a mop up counselling to be conducted by the Commissioner for Entrance Examinations. In view of the pandemic situation due to Covid-19, Mop up Counselling for this academic year 2020-21 is proposed to be conducted in online mode. Candidates who are included in the Kerala State Medical Rank List (2020) published by the Commissioner for Entrance Examination can register fresh options from 12.12.2020 to 16.12.2020, 10 am. Those candidates who have been admitted to MBBS/BDS courses through All India counselling will not be allowed to participate in the Mop Up Counselling.

Candidates, in order to participate in the online Mop Up Counselling can register their options from 12.12.2020 to 16.12.2020, 10 am through the web site www.cee.kerala.gov.in by clicking the menu item 'Mopup Option Registration' available in the **Home page**. Since the probable vacancies that may arise during the course of Mop up allotment have to be filled there in itself, candidates shall give options to all colleges in which they wish to study for the course, if they get an allotment. However, the validity of the options in respect of eligibility for allotment will be determined at the time of the online mop-up counselling based on the admission status of the candidate after the closure of the second phase of admissions, as per the rules regarding the permissible transfers between colleges stated in this notification. If the candidates who have been allotted to MBBS course through previous phases of allotment by CEE get a new allotment through the mop up counselling, previously allotted MBBS seat of the candidate will stand cancelled. Hence candidates should be vigilant while giving options where they want to study for the course if they get an allotment.

Certificate Verification

Facility for certificate verification will be made available after taking into account the vacancies that have arisen after second phase allotment to the course, the probable vacancies that have occurred following student's transfer across the colleges, Candidates, five times the number of anticipated vacancy shall be intimated for attending the certificate verification. Selection for certificate verification will be based on the valid online options and on reservation norms. In order to stick on to the health protocols issued by the Government, candidates are allowed to attend District wise verification centres for certificate verification and can choose the District Centres in which they can attend for certificate verification during option registration itself. Verification centres once selected shall not be changed under any circumstances. Those candidates who have got admission to MBBS/BDS course in previous allotments through CEE need not appear for certificate verification, however they should join the respective colleges with TC, Fee Receipt (if applicable) within the stipulated time if allotted through mop up counselling. Such candidates are also directed to remit the registration fees, if any, well in advance of the date specified failing which they will not be considered for allotments.

Intimations regarding certificate verification will be made available in the candidate portal from 17.12.2020 onwards. Candidates selected for certificate verification should pay the mop up registration fee (to be paid to CEE) Online or through Head Post Offices in Kerala before 4 pm on 18.12.2020, after which they can download the ' Certificate Verification Notice'. It should be noted that the Certificate Verification Notice would be available only after remitting registration fee. Candidates selected for certificate verification should be present at the verification centre on the date and time as mentioned, along with Certificate Verification Notice and other required documents. Mop up allotment to be published on 20.12,2020, will include only those candidates who have successfully verified their documents, and allotted candidates shall join their respective colleges from 21.12.2020 to 24.12.2020 4 pm.

Guidelines for Mop-up counselling

- Candidates allotted to MBBS/BDS courses through All India counselling will not be allowed to participate in the Mop Up Counselling
- During the mop-up counselling, transfer will not be permitted to students admitted in a Government Medical College to another Government Medical College or for

students admitted in a Self Financing Medical College to another Self Financing Medical College.

- Transfer will be permitted to students admitted in self Financing medical colleges to Government Medical Colleges and vice-versa.
- Transfer from NRI seat to Government/Minority seat shall be permitted between two Self Financing colleges or in the same college.

Allotment Schedule

Mop Up Registration fee

- Registration fee for Mop Up Counselling is **Rs.26,260/-**.
- All candidates except those who have been admitted to MBBS course in Government/Self Financing Medical Colleges and those admitted to BDS course in Self Financing Dental Colleges through CEE are exempted from payment of registration fee.
- However those candidates admitted in BDS course in Government Dental Colleges shall pay the excess amount as registration fee.
- Candidates admitted in Ayurveda/Homoeo/Agriculture/Verterinary/Forestry/Fisheries courses should pay the registration fee of Rs.26,260/-.
- Candidates getting allotment to MBBS course who belong to SC/ST/OEC/Children of Registered Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014 - and also wards from Sri Chitra Home/Poor Home and Nirbhaya should pay Rs.1000/- as mop up registration fee. However those candidates who are eligible for fee concession but opted to NRI/Minority seats shall pay registration fee of Rs.26,260/-.

- Candidates eligible for fee concession admitted in previous allotments for MBBS/BDS courses in government seats by CEE will have to pay Rs.1000/ as registration fees.

Documents to be Verified

Candidates who will be selected for Certificate Verification shall appear in person for certificate verification along with the following documents.

1. Certificate Verification Notice.
2. Fee Remittance Slip (as applicable)
3. The candidates who got an admission in any course/college as per the previous allotment conducted by the CEE should produce NOC, Possession Certificate (in original) & the copy of the eligibility certificate (Prospectus clause 11.7.1) and the proof of fee remitted.
4. The candidates who got admission in any of the Govt. Approved Arts & Science colleges in Kerala can participate in the Certificate verification with NOC, Possession Certificate (in original), the copy of the eligibility certificate (prospectus clause 11.7.1) and the proof of fee remitted.
5. Other candidates can participate only with TC and originals of the uploaded certificates, (prospectus clause 11.7.1) and the proof of fee remitted .
6. Eligibility certificate from any Universities in Kerala, in the case of candidates who have passed a qualifying examination other than Higher Secondary Examination/Vocational Higher Secondary Examination conducted by Government of Kerala or the examination conducted by CBSE and CISCE.
7. Migration Certificate, if applicable.
8. Certificate to prove date of birth.
9. Data sheet of KEAM 2020.
10. Physical Fitness Certificate in the relevant format given in Annexure XVII (b) of the Prospectus 2020.
11. Candidates included in the NRI Category List and seeking admission under NRI quota shall have to produce the original documents to prove NRI claim.

Note:

- Candidates who get an allotment through mop up counselling should pay the amount as specified the Allotment Memo (if applicable) and should join the concerned colleges within the time limit specified.
- The annual tuition fee for 2020-21 notified as per G.O.(MS)No.218/2020/H&FWD dated.11.11.2020 has been notified in the website (see annexure). In compliance with the order dated 13.11.2020 of the Hon'ble High court of Kerala in WP(C) Nos.24070,24219, 24725/2020, the maximum fee claimed by the management of the Self-financing colleges has been notified in the website of the Commissioner for Entrance Examinations (see notification dated. 18.11.2020) The candidate allotted to a particular Self-financing college now need only remit the fee as notified in the G.O.(MS)No.218/2020/H&FWD dated.11.11.2020. However, an

Undertaking has to be provided, in the format provided in the website of the Commissioner for Entrance Examinations, to the effect that if any higher fees is fixed by the Hon'ble court or by any other authority as directed by the court such fees shall be remitted. The fee to be remitted in this phase of allotment will be prescribed in the allotment memo.

- Candidates who wish to claim NRI quota seats to MBBS courses in Self Financing Colleges are given provision to upload NRI documents afresh, and candidates are also being permitted to rectify the defects in their NRI documents already uploaded, in vide Notification CEE/4600/2019/KEAM-2020/TA3 dated 10.12.2020. Such candidates can now register NRI options through this Mop up counselling. However, those candidates who will be included in the NRI category list which will be published by CEE before mop-up allotment alone will be considered for NRI seat allotment.
- Since the activities related to second phase of allotment to Medical and allied Courses have not been completed, candidates can register options unconditionally, however, mop up guidelines will be applicable for Mop Up allotment.
- Candidate shall appear in person for certificate verification at the date and time as directed in Verification Notice. Only one parent will be allowed to accompany the candidate to the verification centre, all health protocols including social distancing should be strictly observed.

Liquidated damages as stipulated in clause 12.2.4 of the KEAM 2020 Prospectus shall be applicable to those candidates who lapse admission procedure after being allotted to the course through mop up counselling. The candidates selected for certificate verification will be liable to pay liquidated damages if they fail to report for certificate verification or fail to submit required relevant documents at the time of verification. Hence it is once again reminded that candidates should be most vigilant while participating in the mop up counselling or registering options. These conditions are also applicable for those candidates who are eligible for fee concession.

Vacancies in BDS course will also be filled through an online mop up counselling to be conducted by CEE and details of the counselling will be notified later.
