ORDER

As per the G.O read as 1 st paper above, Government have approved the seat matrix of MBBS/BDS courses in respect of self financing Medical /Dental colleges including DR SMCSI Medical College, Karakkonam (100 MBBS seats) for the academic year 2020-21. The Registar, Kerala University of Health Sciences (KUHS), as per letter read as 2 nd paper above (letter dated 18/11/2020), has reported that DR SMCSI Medical College, Karkkonam has obtained renewal of permission for admission 5 th batch MBBS students against **increased intake of 50 seats** (100 to 150) for the academic year 2020-21 from National Medical Commission Medical Assessment and Rating Board. The Registrar vide letter cited 2 nd and 3rd paper above has also forwarded the additional list of 2 Self financing Medical Colleges ie, Karuna Medical College, Chittur, Palakkad & SUT Medical College, Vattappara, Thiruvananthapuram to which students can be allotted to MBBS Course during the academic year 2020-21. Accordingly, the Director of Medical Education as per the letter read as 5 th paper above has submitted the seat matrix in these self financing Medical Colleges for Government approval.
