MOP UP ALLOTMENT TO BDS COURSE PUBLISHED

Mop Up counselling allotment to fill up the vacant seat in BDS course after the 2nd phase of Mop up allotment has been published in the website www.cee.kerala.gov.in. Guidelines for Mop Up counselling as prescribed in notifications dated. 18.12.2020 & 07.01.2021 is applicable to this phase of mop up allotment.

The details of Mop Up allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. are available in the home page of the candidate and also in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive Mop Up allotment afresh should remit the fees (if any) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment on any date from **15.01.2021 to 18.01.2021** and should join the college allotted, before 3 pm on **18.01.2021**.

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra home, Juvenile home, Nirbhaya home need not remit token deposit to the Commissioner for Entrance Examinations. However if they are allotted seat under Minority/NRI quota in Self-financing Dental colleges, they will have to remit the token fee prescribed to CEE and they will not be eligible for fee concession, also.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the home page of the candidate. The printout of this Data Sheet and other required documents are to be produced before the college authorities at the time of admission.

All the candidates who have an allotment should join the college on or before 18.01.2021 , 3 pm.

Note: Liquidated damages as stipulated in clause 12.2.4(c)(ii) of the KEAM 2020 Prospectus shall be applicable to those candidates who lapse seats after being allotted to the course through Mop up counselling or through any of the prior allotments to BDS course by Commissioner for Entrance Examinations. In addition to this, such candidates will not be included in further BDS allotment process.

Directions regarding filling up of vacant seats (if any) in BDS course after this allotment will be published later.
