### **MOP UP ALLOTMENT FOR MEDICAL (EXCEPT MBBS, BDS COURSES) & MEDICAL ALLIED COURSES** **ALLOTMENT RESULT PUBLISHED**

Mop Up allotment to Medical & Medical allied courses (except MBB/ BDS courses) has been published in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). Allotment details such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. are available in the home page of KEAM 2020-Candidate portal. The allotment details are also available in the Allotment Memo, which can be printed from the home page of candidate portal.

Candidates who get the Allotment shall have to join at the allotted college before 3 pm on 20.02.2021. Before join the college, those candidates who are demanded to pay the Commissioner for Entrance Examinations fee (specified in the allotment memo as 'fee to be paid at CEE') shall have to remit the requisite CEE fee by way of Online Payment or any of the Head Post Offices in Kerala. Candidates eligible for fee concession need not pay the tuition fee. Whether a candidates is eligible for fee concession is specified in his/her KEAM 2020 Data Sheet. Candidates are advised to report at the allotted college with in the stipulated time by producing the Allotment Memo, KEAM Date Sheet and other original documents/Certificates specified in Clause 11.7.1 of the KEAM prospectus.

College authorities shall approve and submit the list of admitted candidates through online Admission Management System (OAMS) at 4.00 pm, 20.02.2021. Candidates are instructed to verify their joining status by logging into the candidate portal.

Subsequent vacancy filling allotment, if any, will be conducted by considering the online options of the candidates who have submitted online options for this Online Mop Up allotment. The detailed notification in this regard will be published in due course.

**Note: Liquidated damages as stipulated in clause 12.2.4(c)(ii) of the KEAM 2020 Prospectus shall be applicable to those candidates who lapse seats after being allotted in Mop up counselling or admitted through any of the prior allotments by Commissioner for Entrance Examinations. Moreover, such candidates shall not be considered for further allotment process**
