## ADMISSION TO ENGINEERING/ARCHITECTURE/PHARMACY COURSES 2020 CANDIDATES CAN REGISTER NEW OPTIONS FOR ONLINE MOP UP ALLOTMENT

The activities related the Up Allotment for admission to Mop to Engineering/Architecture/Pharmacy Courses the Government/Aided Engineering/ in Architecture /Pharmacy colleges for the year 2020-21 will commence on 16.11.2020 (Monday). The Mop-Up allotment is conducted for filling the vacancy existing in Government/Aided Engineering/Architecture/Pharmacy colleges. Candidates who have figured in the rank list published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 6 in the KEAM 2020 Prospectus can participate in the Mop Up allotment. However those candidates who has already taken admission in any of the Private selffinancing Engineering/Architecture/Pharmacy colleges cannot take part in Mop-Up allotment. Candidates who got admission in Government/Aided /Govt. controlled colleges in the previous phases, those who have not taken admission after allotment, those who have obtained Transfer Certificate after admission and those who have not yet received any allotment can participate in this Mop Up Allotment process. Those candidates who have already been admitted in a Government/Aided college/course, and if they get an allotment through this Mop Up allotment will lose the existing admission. Candidates can register options to all the courses existing in Government/Aided colleges to which the candidate wish to join as the newly vacant seats due to transfer of students who have already secured admission, will also be filled in this allotment. The options given by the candidates for previous allotment will not be considered for Online Mop up allotment. Those candidates who have not registered their options within the stipulated time will not be considered for this allotment.

## The schedule for the Mop-Up allotment is given below

16.11.2020	Website opens for Option Registration
17.11.2020, 3.00 pm	Time for Option registration ends
18.11.2020	Mop Up Allotment
20.11.2020, 4.00 PM	Last Date for joining the allotted college

Online Option Registration is mandatory in this phase. Candidates who wish to

participate in the Mop up Allotment shall have to log on to their home Page provided in the

website www.cee.kerala.gov.in by giving their Application Number & Password through the link "KEAM 2020 - Candidate Portal". Then by clicking the Menu item 'Option Registration',

candidate can register their options online from 16.11.2020 to 17.11.2020, 3.00 PM

The candidates who get allotment in this phase shall have to join the allotted college

with all the original certificates as given in the prospectus clause 11.7.1 before 20.11.2020,

**4.00 pm** after remitting the fee, if any, to be paid to the Commissioner for Entrance

Examinations by way of Online Payment or through any Head Post Offices in Kerala. The balance

tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted

colleges at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for educational concessions as

is given to OEC/Candidates eligible for fee concession as per GO(Ms)No.25/2005/SCSTDD dated:

20.06.2005/Children of Fisherman/Inmates of Sri Chithra home, Nirbhaya home & Juvenile

home allotted under Government Quota are exempted from payment of fees.

All the College Principals should approve and submit the list of admitted candidates

through Online Admission Management System (OAMS) at 5.00 pm on 20.11.2020.

Candidates who receive allotment should have attained the eligibility for admission as

per Clause 6 of the Prospectus at the time of admission.

**Note:** The vacancies, if any, remaining in Engineering/Architecture/Pharmacy courses in

Government/Aided colleges after 5.00 Pm on 20.11.2020 shall be filled up either through further

Online Mop-Up allotment by considering the same options registered by the candidates for this

Online Mop Up round or through Spot Allotment, which will be notified later.
