## MOP UP COUNSELLING TO B.PHARM COURSE IN GOVT. PHARMACY COLLEGES FACILITY FOR ONLINE OPTION REGISTRATION

As the last date for admission to B. Pharm course for the year 2020-21 has been extended up to 15.02.2021, one more Mop Up counselling will be conducted for filling the vacancies existing in Government Pharmacy colleges. The allotment to EWS quota seats in Government Pharmacy colleges will also be conducted in this phase of allotment. Candidates who are included in the B. Pharm rank list published by the Commissioner for Entrance Examinations can register online options from 01.02.2021 to 04.02.2021, 3.00 pm. However those candidates who have been admitted in MBBS/BDS courses through previous allotments of Commissioner for Entrance Examinations and those candidates who have been admitted in B. Pharm course in Government Pharmacy colleges through previous allotment of Commissioner for Entrance Examinations cannot participate in Mop Up Counselling.

Candidates who wish to participate in Mop Up counselling can register their option from 01.02.2021 to 04.02.2021, 3.00 pm through the website <u>www.cee.kerala.gov.in</u> by clicking the menu item **'B. Pharm option Registration'** available in the home page. Based on the options received up to 04.02.2021, 3.00 pm allotment will be published on 05.02.2021, evening. Those candidates who receive an allotment through the Mop-Up counselling shall have to join to allotted colleges on or before 10.02.2021, 3.00 pm, after remitting the fees show in the allotment memo.

## ALLOTMENT SCHEDULE

Note: If candidates who have been allotted to Medical allied courses through previous allotment by Commissioner for Entrance Examinations, get allotment through this Mop Up counselling, previous allotment of the candidate will stand cancelled. As the Mop Up counselling is the last phase of allotment to B. Pharm course, candidates shall give option only to those colleges where they wish to join if they get allotment. Hence candidates should be vigilant while giving options for considering in the online Mop Up allotment. Liquidated damages as stipulated in Keam 2020 prospectus shall be applicable to those candidates who lapse seats after being allotted to a college through Mop-Up counselling.

The vacancies existing in Private Self-financing Pharmacy colleges will be filled by the colleges itself. The following Self-financing Pharmacy colleges, can also conduct allotments with in the time line on the basis of getting university affiliation.
