### **ADMISSION TO ENGINEERING/ARCHITECTURE/PHARMACY COURSES -2020** **II PHASE MOP UP ALLOTMENT-OPTION CONFIRMATION IS MANDATORY**

The activities related to the II Phase Mop Up Allotment for admission to the vacancy existing after the I Phase Mop Up allotment in Engineering/Architecture/Pharmacy Courses in the Government/Aided Engineering/ Architecture /Pharmacy colleges for the year 2020-21 will commence from **24.11.2020 (Tuesday)**. The second phase allotment is conducted on the basis of the Online options filed by the candidates for first phase Mop up allotment from 16.11.2020 to 18.11.2020, 12.00 noon. Those candidates who have got allotment in Engineering/Architecture/Pharmacy courses through the first phase Mop up allotment and those who do not join to the course will lose their options in the concerned stream. Those candidates who will get an allotment through this Mop Up allotment will lose their current admission in Government/Aided Engineering/Architecture/Pharmacy colleges received through previous allotments. Those candidates who do not confirm options within the time limit will not be considered for second phase Mop Up allotment.

#### **Option confirmation is mandatory for Mop Up allotment**

Candidates who wish to participate in the Mop up Allotment shall have to log on to their home Page provided in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) by giving their Application Number & Password through the link "KEAM 2020 - Candidate Portal". Then by clicking the Menu item 'Option Confirmation', candidate can confirm their options online from 24.11.2020 to 26.11.2020, 4.00 PM. Those candidates who do not confirm options within the time limit will not be considered for allotment. Candidates can also re-arrange or delete the existing higher options within the time limit. Those candidates who get an allotment through this phase should

join the concerned colleges, otherwise the conditions prescribed in the prospectus clause 12.2.4 c(i), (ii) will be applicable.

The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the prospectus clause 11.7.1 before **30.11.2020, 4.00 pm** after remitting the fee, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any Head Post Offices in Kerala. The balance tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for educational concessions as is given to OEC/Candidates eligible for fee concession as per GO(Ms)No.25/2005/SCSTDD dated: 20.06.2005/Children of Fisherman/Inmates of Sri Chithra home, Nirbhaya home & Juvenile home allotted under Government Quota are exempted from payment of fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **5.00 pm on 30.11.2020**.
