**ALLOTMENT TO MBBS/BDS/ AGRICULTURE/VETERINARY/FORESTRY/FISHERIES /  
AYURVEDA/HOMEO COURSES**  
**FACILITY FOR OPTION CONFIRMATION AND OPTION REGISTRATION**

The activities related to the second phase of allotment to MBBS/BDS/Agriculture/Veterinary/Forestry/Fisheries courses and first phase of allotment to Ayurveda/Homeo courses began on **05.12.2020**. Candidates can register online options to Ayurveda, Homeo courses and can also register options for the MBBS course in newly included Self Financing Medical colleges - Karuna Medical College Palakkad (KMM) and SUT Academy of Medical Sciences, Thiruvananthapuram(SUC) . Allotment to Siddha, Unani courses are excluded in this phase.

As per the Letter No. A3/330/2020/AYUSH dated. 01.12.2020 allotment to 15% of the seats to BAMS Course in Self-Financing Ayurveda colleges in Kerala irrespective of candidate's domicile will also be done by the Commissioner for Entrance Examinations. Allotment to these seats will be done considering the online options received from the candidates in this phase and based on the State Ayurveda rank list 2020 published by the Commissioner for the Entrance Examinations.

**Online Option Confirmation is mandatory**

The Candidates who want their higher order options in MBBS/BDS and Agriculture/Veterinary/Forestry/Fisheries courses to be considered in the second phase of allotment and Ayurveda/Homeo courses in the first phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added Courses/Colleges if applicable, from **05.12.2020 to 09.12.2020, 11.00 am**, through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). Online option confirmation is mandatory for those who have got admission and those who have no allotment as per the first phase allotment, to consider them in the second phase allotment in the case of MBBS/BDS and Agriculture/Veterinary/Forestry/Fisheries courses. But for those who do not confirm their options after first phase of admission, the admission in the first phase shall be retained.

On the basis of options received up to **11.00 am on 09.12.2020**, the second phase allotment to MBBS/BDS and Agriculture/Veterinary/Forestry/Fisheries courses and first phase allotment to Ayurveda/Homeo courses will be published in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) on **10.12.2020**. Candidates who receive allotment in this phase shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations, at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **11.12.2020 to 15.12.2020, 3 pm**. The list of Post Offices having facility for fee payment is available in the website. After remitting the fee/balance fee (if applicable), the candidates should join the course/college allotted before **4 pm on 15.12.2020**.

### DETAILED SCHEDULE OF THE ALLOTMENT

05.12.2020	Website opens for Online Option Confirmation and for enabling re-arrangement of higher options/deletion of unwanted options and for registration of fresh options to the newly added Courses/Colleges for Medical and Medical Allied courses ( except Siddha Unani courses )
09.12.2020 (11.00 am)	Time for Online Option Confirmation and re-arrangement/ deletion/ addition of options ends.
10.12.2020	<b>Publication of Allotment</b>
11.12.2020 to 15.12.2020, 3.00 pm	Candidates who receive allotment should remit the fee/balance fee (if applicable) payable to CEE in any of the Head Post Offices in Kerala or by way of online payment and should report before the college authorities to join the allotted college/course for Medical & Medical allied courses ( except Siddha Unani courses ).
15.12.2020, 4.00 pm	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) for Medical & Medical allied courses.

**Note:** The annual tuition fee for 2020-21 notified as per G.O.(MS)No.218/2020/H&FWD dated.11.11.2020 has been notified in the website (see annexure). In compliance with the order dated 13.11.2020 of the Hon'ble High court of Kerala in WP(C) Nos.24070,24219, 24725/2020, the maximum fee claimed by the management of the Self-financing colleges has been notified in the website of the Commissioner for Entrance Examinations ( see notification dated. 18.11.2020) The candidate allotted to a particular Self-financing college now need only remit the fee as notified in the G.O.(MS)No.218/2020/H&FWD dated.11.11.2020. However, an undertaking has to be provided, in the format provided in the website of the Commissioner for Entrance Examinations, to the effect that if any higher fees is fixed by the Hon'ble court or by any other authority as directed by the court such fees shall be remitted. The fee to be remitted in this phase of allotment will be prescribed in the allotment memo.

#### **FEES:**

The details of fee for the Medical & Medical allied courses, in various colleges is available in the website. Fee structure in the case of Self Financing Ayurveda colleges is subject to change as decided by the AFRC/Government in due course.

#### **TOKEN FEES**

Those candidates who get allotment to MBBS course in Self-financing colleges should pay an amount of Rs.3 lakhs and NRI candidates should remit fee of Rs.5 lakhs to CEE. Those candidates who get allotment to BAMS course in self-financing Ayurveda colleges and candidates who get allotment to BDS course (including NRI) should pay an amount of Rs.1 lakh to CEE.

Those candidates who get allotment to Government Medical/Dental/ Ayurveda/ Homoeo/Agriculture/ /Veterinary/Fisheries/Forestry courses should pay the complete fee to CEE. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra home, Juvenile home, Nirbhaya home need not remit token fees to the Commissioner for Entrance Examinations. However if they are allotted seat

under Minority/NRI quota in Self-financing Medical/Dental colleges they will have to remit the token fee prescribed to CEE and they will not be eligible for fee concession.

**Note:**

- 1) Candidates are advised to file options to the courses/colleges to which they are sure to join and continue studies if allotted, at the time of registration of options.
- 2) Those NRI candidates who are provisionally given NRI status as per the directions of Admission Supervisory Committee in order No. ASC 100/20/Medical & Medical Allied courses/NRI, dated. 22.10.2020 and who have been given provisional allotment should clear the defects before 08.12.2020 01.00 pm . Those candidates who fail to upload the documents as specified within the time limit will lose the allotment, if any, received in the first phase and the category claim of the candidate will also stand cancelled.
- 3) The candidates whose results in the respective rank lists have been withheld can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they upload the required documents to clear the defects and release their ranks before 5 pm on 07.12.2020
