# SECOND PHASE OF ONLINE MOP UP COUNSELLING TO BDS COURSE OPTION CONFIRMATION IS MANDATORY

The activities related to the II Phase Mop Up Allotment for admission to the vacancies existing after the I Phase Mop Up allotment to BDS Course in the Government/Self-financing Dental colleges for the year 2020-21 has commenced from **31.12.2020**. The second phase allotment is conducted on the basis of the Online options filed by the candidates for first phase Mop up allotment from 17.12.2020 to 20.12.2020, 01.00 pm. In view of the pandemic situation due to Covid-19, Second Phase of Mop up Counselling for BDS course will also be conducted in online mode.

#### Guidelines for Mop-up counselling

- (i) Those candidates who have got allotment in BDS Course through the first phase Mop up allotment and those who have not joined the course will lose their options and those candidates who got admission in MBBS course in any Medical Colleges and BDS course in Government Dental college through previous allotment and though stray vacancy round of allotment (28.12.2020) conducted by the Commissioner for Entrance Examinations will not be allowed to participate in the Mop Up counselling.
- (ii) Those candidates who have been allotted through All India counselling will not be allowed to participate in the Second Phase Mop Up Counselling.
- (iii) Transfer will be permitted in the mop-up counselling to students admitted in Self Financing Dental colleges to Government Dental colleges.
- (iv) Transfer from NRI seat to Government seats or to minority seats between two Self Financing colleges or in the same college shall be permitted.

### **Allotment Schedule**

31.12.2020	Web site opens for online option registration
02.01.2021, 3 pm	Option registration facility ends.
03.01.2021	Publication of Allotment
04.01.2021 to 07.01.2021 4.00 pm	Candidates who receive allotment should remit the fee/balance fee (if applicable) payable to CEE in any of the Head Post Offices in Kerala or by way of online payment and should report before the college authorities to join the allotted college.

#### Option confirmation is mandatory for Mop Up allotment

Candidates who wish to participate in the Mop up Allotment shall have to log on to their home Page provided in the website <a href="www.cee.kerala.gov.in">www.cee.kerala.gov.in</a> by giving their Application Number & Password through the link "KEAM 2020 - Candidate Portal". Then by clicking the Menu item 'Option Confirmation', candidate can confirm their options online from 31.12.2020 to 02.01.2021, 3.00 PM. Those candidates who do not confirm options within the time limit will not be considered for allotment. Candidates can also re-arrange or delete the existing higher options within the time limit. Those candidates who get an allotment

through this phase should join the concerned colleges, otherwise the conditions prescribed in the prospectus clause 12.2.4 will be applicable.

The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the prospectus clause 11.7.1 before **07.01.2021**, **4.00 pm** after remitting the fee, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any Head Post Offices in Kerala. The balance tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission.

#### **FEES**

- Fees for BDS course is available in the website. All candidates getting allotment to BDS course must pay the fee prescribed in the allotment memo. Candidates should pay the amount as specified the allotment memo (if applicable) and should join the colleges concerned within the time limit specified.
- Candidates get allotment to BDS course who belong to SC/ST/OEC/Children of Registered Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014 and also wards from Sri Chitra Home/Poor Home and Nirbhaya are exempted from payment of fee. However those candidates who are eligible for fee concession admitted to NRI/Minority seats shall pay the fee as applicable.
- Candidates those who have remitted any fee for the allotment to Medical and Medical Allied courses to the Commissioner for Entrance Examinations as per the previous KEAM allotments need to pay the balance amount only. Whereas the amount paid by the candidates admitted through previous KEAM allotments in Engineering/Architecture and Pharmacy courses will not be considered for the allotment to BDS course.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at 5.00 pm on 07.01.2021.
