

NOTIFICATION KEAM- 2020

ADMISSION TO MEDICAL COURSES KERALA ATTENTION NRI CANDIDATES

NRI candidates seeking admission to Medical/Dental courses in Self Financing Colleges for the academic year 2020 were directed to submit the documents as stipulated in GO (Rt) No. 375/2020/H & FWD dtd. 22.02.2020 in proof of the candidate's NRI claim. However in view of the pandemic situation prevailing, certain relaxations have been implemented in submitting the NRI documents and AFC has issued fresh directions as per ASC 100/2020/Medical &Allied courses/NRI dated 22.10.2020.

NRI Document to be submitted as per new directions

- 1.a. Passport Copy I & Visa/Green Card/OCI documents of their respective sponsors. The job of the sponsor should be mentioned in any of the above documents.
 - b. In case the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by the Embassy/Consulate authorities.
 - c. Certificates issued by the Embassy/Consulate stating that the sponsor is an Overseas Citizen of India or the Green Card documents shall be accepted in lieu of the overseas employment Certificate issued by the employer and attested by the embassy.
 - d. In view of the pandemic situation, if the Embassy/Consulate have not started regular normal function and if they are unable to produce Embassy attested documents, the aspirants are given one month's time or till two days prior to the second allotment by the Commissioner for Entrance Examinations, whichever is earlier to produce the above documents from the embassy or consulate authorities.

However The sponsor has to submit sworn affidavit notarized by the Notary Public, as per the rules and regulations prevailing in the respective countries, where the sponsor is presently working, undertaking that the sponsor shall submit the documents as per clause C of the GO (Rt) 375/2020/H & FWD dtd. 22.02.2020 within the time limit prescribed by the CEE in this notification ie 09.11.2020, 12.00 noon. In case the sponsor is already in India the affidavit shall be notarized by any of the Notary Public in a stamp paper worth Rs.200/- in the prescribed format appended to the Notification available in the website.

2. The Visa of the sponsor should be valid till the closing date of the admission in respect of medical course admission.

Note: If the validity of the Visa has expired the copy of the document, online acknowledgement seeking extension of Visa should be produced.

3. The certificate clearly establishing the relationship of the sponsor with the candidate obtained from Revenue authorities as per GO(Ms) No. 243/14/H & FWD dtd. 06.08.2014.

<u>Note</u>: Relationship between the candidate and his or her father/mother which are recorded in educational certificate shall be accepted.

4. The candidate shall produce sworn affidavit from the sponsor in the stamp paper Rs.200/-, notarized by the Notary Public, disclosing that the student is dependent of the sponsor and all the expenses ie. Tuition fee and Special fee of the candidate for the entire course period will be borne by the sponsor in the prescribed format appended to the Notification available in the website.

<u>Note</u>: In case the sponsor is abroad the sponsor has to submit the sworn affidavit notarized by the Notary Public, as per the rules and regulations prevailing in the respective countries, where the sponsor is presently working.

Those candidates who have been provided with any memo to rectify the defects in their NRI documents shall rectify the defects. Candidates can view their profile page available in the website www.cee.kerala.gov.in through the link 'KEAM-2020 Candidate Portal' by giving their Application Number and Password. Then by clicking the menu item 'Memo details' provided in the profile page, candidates can view the details of defects in their NRI documents uploaded. Candidate can rectify the defects in their NRI documents if any, as directed above from 03.11.2020 to 09.11.2020, 12.00 Noon. If the candidates fail to rectify the defects according to the instructions, the candidate will not be considered for allotment to MBBS/BDS courses under NRI Quota in Self Financing Colleges. The candidates will not be given another chance to rectify the defects in NRI documents in due course of the admission/ allotment to the said seats.

1. G.O (Rt) No. 375/2020/H&FWD dated 22.02.2020

ORDER

- The Government of Kerala has issued a G.O dated 22.02.2020 regarding the submission of documents by the NRI candidates for admission to the Medical Courses for the academic year 2020-21. On the basis of the representation received from the aspirants and the clarification sought for by the CEE, the following directives are issued.
- 2. In clause 'c' of the Government order under reference,

"in case, the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by Embassy/Consulate authorities."

It was brought to notice of the committee that, in view of the present pandemic situation, many of the embassy/consulate have not started

regular normal functioning and their inability to produce the embassy documents. Hence, the aspirants are given a month time from the date of allotment by the CEE or two days prior to the 2nd allotment by the CEE whichever is earlier to produce the above documents from the embassy/consulate authorities.

- 3. In view of the clarification issued to clause c the Committee hereby further clarify that the sponsor has to submit sworn affidavit notarised by the Notary Public, as per the rules and regulations prevailing in the respective countries, where the sponsor is presently working, undertaking that the sponsor shall submit the documents as per clause c of the Government order and as per the clarification issued by the Committee in this directives. In case the sponsor is already in India, the affidavit shall be notarised by any of the notary public in a stamp paper worth Rs. 200/-.
- 4. It is also clarified that the sworn affidavit referred to in clause (f) of the Government order shall be sworn and notarised by any of the notary public in a stamp paper worth Rs. 200/-. In case the sponsor is abroad, the sponsor has to submit the sworn affidavit notarised by the Notary Public, as per the rules and regulations prevailing in the respective countries, where the sponsor is presently working
- 5. Email this order to the Commissioner for Entrance Examinations and the Principals of the Colleges/ Institutions, who are conducting the Medical & Allied Courses.
