The Director of Technical Education, as per the letter read as 2nd paper above, has recommended the request and also informed that as both these programmes belong to the Mechanical Engineering branch, there will not be any financial commitment to Government and that the faculty, staff and infrastructure used for Production Engineering can be used for the additional batch of Mechanical Engineering.

APJ Abdul Kalam Technological University has issued NOC for the closure of the B.Tech Production Engineering course being conducted in the college and to start an additional batch of B.Tech Mechanical Engineering in its place with an intake of 60 students in the academic year 2020-21. The AICTE Expert Committee has also recommended the changes in the Mechanical Engineering branch of the institution .


