B.PHARM COURSE IN GOVERNMENT COLLEGES
MOP UP ALLOTMENT PUBLISHED

Mop Up counselling allotment to fill up the vacant seats in B.Pharm course in Government Pharmacy colleges for the academic year 2020-21 has been published in the website www.cee.kerala.gov.in. Mop Up allotment has been prepared based on the online options registered by the candidates from 01.02.2021 to 04.02.2021 till 3.00 pm. EWS quota seats in Government Pharmacy colleges have been included in this phase.

The details of Mop Up allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. are available in the home page of the candidate and also in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page and should submit before the college authorities while taking admission.

Candidates who receive Mop Up allotment should remit the fees /balance fee (if any) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the Head Post Offices in Kerala or by way of Online Payment on any date from **06.02.2021 to 09.02.2021, 3.00 pm** and should join the college allotted, before 3 pm on **09.02.2021**.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidate by clicking the menu item '**Data Sheet**' available in the home page of the candidate. The printout of this Data Sheet, allotment memo, and other required documents as prescribed in prospectus clause 11.7.1 are to be produced before the college authorities at the time of admission. Those candidates who do not remit fee/balance fee (if applicable) and join their respective allotted colleges will lose their allotment.

Note:

1. Candidates currently admitted in Medical/Allied courses have that admission cancelled automatically if re-allotted to B.Pharm course through this online Mop-Up allotment process. Hence, such candidates must join the B.Pharm course allotted to him/her in this phase failing which they will lose both seats.
2. Candidates not joining the seat allotted to them in the Mop-Up allotment will be subjected to the penalty clauses of the KEAM -2020 prospectus.

All the college authorities should intimate the details of admission of the candidates who report within the stipulated time and should approve and submit the list of admitted candidates before 4.00 pm on 09.02.2021.
