ADMISSION TO MEDICAL & MEDICAL ALLIED COURSES, KERALA
ONLINE FACILITY FOR SUBMISSION OF NEET (UG) -2026 RESULT

The admission to the State Quota seats in Government Medical/Dental Colleges, the entire MBBS/BDS seats in Self Financing Medical/Dental Colleges including minority Quota/NRI Quota and the Medical seats earmarked for candidates irrespective of their domicile for the academic year 2026-27 shall be through a Centralized Counselling conducted by the Commissioner for Entrance Examinations from the rank list prepared by the Commissioner for Entrance Examinations based on the score of the candidates in NEET-UG 2026. Moreover, the admissions to other Medical Courses such as Ayurveda (BAMS), Homoeopathy (BHMS), Siddha (BSMS) and Unani (BUMS) and Allied courses such as Agriculture (BSc (Hons) Agri), Forestry (BSc (Hons.) Forestry), Veterinary (BVSc. &AH), Fisheries (BFSc.), BSc (Hons) Co-operation & Banking/BSc (Hons) Agri. Business Management, BSc (Hons) Horticulture, BSc – Msc (integrated) Biology/Micro biology, BSc (Hons) Climate Change & Environmental Science, B.Tech Biotechnology (Under KAU) course in the State for the year 2026-2027 will also be made from the rank list prepared by the Commissioner for Entrance Examinations based on the score of the candidates in NEET-UG 2026. **Candidates who have appeared in NEET**

(UG) – 2026 and opting for admission to Medical courses such as MBBS, BDS, Ayurveda, Homoeopathy, Siddha, Unani and Allied Courses such as Agriculture, BSc (Hons) Horticulture, BSc – Msc (integrated) Biology/Micro biology, Co-operation and Banking, B.Tech (Bio Tech), Climate Change, Forestry, Veterinary and Fisheries shall have to submit online their NEET (UG) – 2026 result details to the Commissioner for Entrance Examinations for preparing the respective State rank lists. The online facility for submission of NEET (UG) – 2026 result details will be available in the website **www.cee.kerala.gov.in** till **10.08.2026, 12:00 noon.**

Candidates who do not submit their NEET (UG) - 2026 results to the Commissioner for Entrance Examinations within the stipulated time shall not be considered for the preparation of rank list for Medical & Medical Allied courses.

Candidates who have already submitted application for admission to Medical & Medical Allied courses under KEAM 2026 and who have qualified in the NEET (UG) 2026 conducted by the NTA, as per the eligible criteria mentioned in the prospectus clause 9.7.5 (ii) & (iii) can submit NEET result to the Commissioner for Entrance Examinations online. There will be no opportunity to the submit the mark details later under any circumstances .

STEPS FOR SUBMITTING NEET RESULT

- Access the **website www.cee.kerala.gov.in**
- Click the link **‘KEAM 2026-Candidate Portal’** and provide KEAM-2026 Application number and Password to enter the Home Page of the candidate.
- Click the Menu **‘NEET Result Submission’** and provide NEET (UG)-2026 Roll Number, NEET (UG)-2026 Application Number and NEET (UG)- 2026 Date of Birth.
- Verify the score card for NEET (UG)-2026 –Candidate’s name, Name

of Father, Name of Mother, NEET (UG) result details shown in the screen with NEET (UG) 2026 NEET Percentile Score, All India Rank for counseling etc.

- If the details are correct, click the '**Verified and Submit**' button.

(Note:- The procedure of submission of NEET result will be completed only when the '**Verified and Submit**' button is clicked).

- Take the printout of '**NEET Result Submission Report**' and keep it with the candidate for future use.

Candidates should not send/upload the NEET Score Card or NEET Result Submission Report to the Commissioner for Entrance Examinations. All candidates are requested to go through the Government approved Prospectus for admission to Professional Degree courses-2026, available in the website **www.cee.kerala.gov.in**
