THIRD PHASE ALLOTMENT TO ARCHITECTURE COURSE **CANDIDATES CAN REGISTER NEW OPTIONS**

The activities related to the third phase allotment for the Architecture course for the year 2026-27 have commenced.

Tentative schedule

10.08.2026	Opening of the website for online option registration
12.08.2026, 11.59 PM	Closure of online option registration facility
13.08.2026	Publication of provisional allotment
14.08.2026	Publication of Final allotment
17.08.2026 to 19.08.2026, 4.00PM	Candidates who get allotment shall have to pay the fees to the Commissioner for Entrance Examinations as shown in the allotment memo through online payment and should join the allotted colleges

Online Option Registration

Candidates who wish to participate in the third phase allotment shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link '**KEAM 2026 – Candidate Portal**'. Then by clicking the Menu item '**Option Registration**', candidate can register their options online from **10.08.2026 to 12.08.2026, 11.59 PM**.

Online option registration is must for those who got allotment/admission and those who got no allotment as per the previous allotments, to consider them in this phase. But those who got an allotment/admission in the

previous phases and do not register the options the admission through the allotment in the previous phase shall be retained. Those candidates who get allotment in this phase and do not join the college on or before the date prescribed for the same will lose their allotment in the last phase and the allotment in this phase.

Option Registration Fee:

Those candidates who wish to register options will have to remit registration fee of Rs.2,000/- (Rupees Two Thousand Only) to the Commissioner for Entrance Examinations subject to the following conditions. Those candidates who wish to register options afresh and who got allotment in the previous phases and did not take admission will have to remit registration fee. The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent on allotments. Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/SCSTDD Dated 20.06.2005 and G.O. (Ms)No.10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chitra Home will have to remit Rs.500 /- (Rupees Five Hundred only) as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. Registration Fee of those candidates who do not take admission within the stipulated time after getting an allotment will be treated as penalty and will not be refunded. **Registration Fees can be remitted by way of online payment.**

This phase of allotment will be the last phase allotment for Architecture Course for this year made by the Commissioner for Entrance Examinations to Government and Private Self Financing Architecture Colleges. The seats remain vacant in Government and Private Self Financing Architecture Colleges after this allotment will be filled by the College authorities concerned observing the conditions, rules and regulations contained in the KEAM 2026 Prospectus and Government Orders issued in this regard.
