ALLOTMENT TO P G PHARMACY COURSES (M.PHARM) - 2026 **ONLINE OPTIONS INVITED**

The activities related to the first phase of centralized allotment to the Post Graduate Pharmacy Courses (M.Pharm) for the year 2026 have commenced. Candidates who have applied for admission to the M.Pharm courses for the year 2026 can register their options on the website **www.cee.kerala.gov.in** up to **06.09.2026, 05:00 PM**. Candidates can access their home page by entering their Application Number and Password on the web page available after clicking on the link '**M.Pharm 2026 - Candidate Portal**' on the above website. Candidates can then register their options online by clicking the menu '**Option Registration**'.

The list of Pharmacy Colleges and Courses to which the Commissioner for Entrance Examinations makes allotment is provided on the candidate's home page. Candidates can submit options as per their priority for the Course-College combinations in the option list. A candidate should only give options to a Course-College combination if they are sure to join the course and college, if allotted. Options registered online alone will be considered for allotment to the courses. Options sent to the Office of the Commissioner for Entrance Examinations via Post, Fax, or Email will not be processed or considered for allotment.

Option Registration Fee:

Those candidates who wish to register options will have to remit registration fee of Rs.5,000/- (Rupees Five Thousand Only) to the Commissioner for Entrance Examinations. The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent

on allotments. Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/SCSTDD Dated 20.06.2005 and G.O.(Ms)No.10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chitra Home will have to remit Rs.500 /-(Rupees Five Hundred only) as Registration Fee. The Registration Fee of such candidates who take admission in the allotted college/course will be adjusted in the caution deposit. The registration fee of those candidates who do not get allotment will be refunded. The allotment to Colleges / Courses will be subject to the recognition of All India Regulatory Bodies / Affiliation from the Universities concerned.
