ADMISSION TO INTEGRATED FIVE YEAR LLB COURSES-2026
VACANT SEAT- FINAL ALLOTMENT PUBLISHED

The Vacant Seat Final Allotment for admission to Integrated Five Year LLB course 2026 to fill up vacant seats in the Government and Self Financing Law colleges is published in the website **www.cee.kerala.gov.in**. Vacant Seat Allotment to Integrated Five Year LLB Courses have been prepared after addressing valid complaints received within stipulated time regarding Provisional Allotment List published on 19.09.2026. Vacant Seat allotment has been prepared on the basis of the conditions stipulated in Integrated Five Year LLB Prospectus clause 18.

To view the Allotment Result, candidates should log on to the **‘Integrated Five Year LLB 2026-Candidate Portal’** by submitting their Application Number and Password. By clicking on the link **‘Allotment Result’**, candidates can view their Allotment Result. It is necessary to take the printout of the Allotment Memo. The allotted candidates should join at the allotted colleges on any date from 23.09.2026 to on or before **26.09.2026, 3:00 PM**, along with all required documents specified in the Allotment Memo as per Prospectus clause 19.

General Rules of Vacant Seat Allotment:

1. If no seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, shall prevail, and if a seat is allotted to the

candidate in the vacant seat allotment, the existing admission, if any, will stand cancelled and the candidate shall have to accept the new allotment.

2. The seats received through vacant seat allotment cannot be changed further at any instance.
3. Candidates who are allotted a seat in the vacant seat allotment (irrespective of the admission status) will not be eligible for any subsequent allotments.
4. Allotment shall be subject to the final order/affiliation/approval of the Govt./Bar Council of India/University concerned.
5. Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) before **26.09.2026, 4:00 PM**. Candidates who do not join the college within the stipulated time will lose their present allotment, if any.
